3.0 Main report 3.1 Key Issues At the meeting of the Standards and Business Committee held on 20th October, the following motion, which was proposed by Councillor Doran and seconded by Alderman McCoubrey, was referred to the Committee for consideration: **Priority for our Local Traders** 3.2 "This Council notes the significant contribution that local independent traders, small businesses, and market stallholders make to Belfast's economy, tourism offering and community life. This Council further notes that major Council organised events such as the Belfast Maritime Festival, Christmas Market, and other seasonal events attract large crowds and generate substantial commercial opportunities. Accordingly, this Council resolves that for all Belfast City Council organised or Council supported events involving trader or vendor pitches, priority shall be given to traders who are residents or ratepayers within the Belfast City Council area. Council officers should develop and publish a transparent process for allocating pitches which: gives first refusal to eligible local traders before any external operators are invited: ensures fair opportunity across different sectors and communities; and supports the Council's commitment to local economic growth and inclusive prosperity." **Proposer:** Councillor Jordan Doran **Seconder:** Alderman Frank McCoubrey The motion calls upon the Council to give priority to traders who are residents or ratepayer 3.3 within the Belfast City Council area at Council organised or Council supported events involving trader or vendor pitches. 1.0	Purpose of Report	or Summary of main Issues							

The purpose of this report is to provide an update on the Notices of Motion and Issues Raised in Advance allocated to the City Growth & Regeneration (CG&R) Committee.

3.0	Main report
3.1	At the SP&R Committee meeting on 25 th October 2019, members agreed "that this Council notes that other Councils produce a monthly status report in relation to Notices of Motion; and agrees Belfast City Council adopts a similar practice and produces a monthly Notice of Motion Update which will be brought to each full Council Meeting.
3.2	It was subsequently agreed that quarterly updates would be brought to the council's statutory committees providing a regular update on the progress of each motion for which the committee is responsible for. At the SP&R Committee on 20th November 2020 , members approved the arrangement for the future management of motions, which included recommendations that Notices of Motion could be closed for one of two reasons:
	 Category 1 – Notice of Motion contained an action that has been completed. All Notices of Motion within this category contained a specific task that has since been complete. It is worth noting that, when Committee agree to action a Motion, there are sometimes additional actions agreed alongside the Motion. As these are not technically part of the Notice of Motion, they are taken forward through normal committee decision making processes. The Notice of Motion can therefore be closed, but additional actions related to it will continue to be progressed and reported to the committee. Category 2 - Notice of Motion has become Council policy or absorbed into a strategic programme of work. These Motions did not contain a specific task that could be completed but rather they are more strategic in nature and require changes in Council policy and/ or strategy for long term outcomes. Those listed within this category have all been agreed by Committee and are now either Council policy or are currently being implemented through a Council strategy that is managed by a Standing Committee through the corporate planning process.
3.3	There are presently nine Notices of Motion and Issues Raised in Advance for which the CG&R Committee is responsible for. Members are asked to approve the recommendation to close one motion (detailed below) and note status updates for the remaining eight motions which remain open. Additional information is included at Appendix 1. Category 1 Recommended Closures: • 289 - Translink - Night-time provision of services

The findings report that Belfast alone accounts for £802million in GVA and supports over 26,000 jobs, many of them entry-level positions providing vital opportunities for young people and new workforce entrants. The full research report is yet to be published. The event also included the first annual update from the Belfast Night Czar. Following previous engagement by the City Centre All Party Working Group (CCAPWG) with the Night Czar in December 2024, it has been agreed that ongoing engagement and closer working arrangements are established between Elected Members and the Purple Flag Steering Group (PFSG). The Night Czar will be invited to the next meeting of the working group (early in the New Year), while enhanced elected member engagement on Belfast's nightlife and nighttime economy will be facilitated by the Chair of the CCAPWG joining the PFSG.

Page 105	9 01/12/2022	Translink - Night-time provision of services	Cllr D Lyons	Notice of Motion — debated at council	Cathy Reynolds	Recommend to close (Category 1) As part of the original motion, council contacted Translink, requesting an extension to the night-time provision to its Metro and Glider bus services. In addition, as part of an amendment, the council also engaged Translink about setting up a free public transport incentive in the run up to Christmas 2023. A four-week Nightmover Service was delivered over the last two-years. In 2023, it started on 24 November 2023, and ran every Friday and Saturday until 22 December 2023 (covering four weekends). The 2023 Nightmover service was impacted by a 24-hour strike on 1 Dec and a 48-hour strike on 15-16 December. In 2024, the Nightmover Service started on 30 November 2024 and ran every Friday and Saturday until 21 December 2024 (also four weekends). As part of community planning the council has mainstreamed related activity within the refreshed Belfast Agenda action plans: "Expand the timetable with a greater service in the evenings and funding for the provision of night-time services", for which Translink are the lead partner. Council had positive engagements with relevant Ministers and continued to work with Translink and other interested stakeholders. Furthermore at the September meeting of the SP&R Committee, members agreed to provide £92.3k of collaborative funding of the Nightmover Service (subject to Executive funding). Initiative starting on Friday 28 November 2025, marks the start of a significant new year-round bus pilot scheme backed by BCC and the NI Executive.
