Chairperson

In the absence of the Chairperson, Alderman Lawlor, the Working Group agreed that Councillor Flynn would act as Chairperson for the duration of the meeting.

Apologies

Apologies for inability to attend were reported on behalf of the Chairperson, Alderman Lawlor, and Councillors Maghie and McCormick.

Minutes

The Working Group agreed that the minutes of the meeting of 5th June were an accurate record of proceedings.

Declarations of Interest

Councillor McAteer declared an interest in relation to item 2(b) "EastSide Partnership Presentation" in that EastSide Greenways was one of her chosen charities as High Sheriff, however, she was not required to leave the meeting whilst the item was being discussed.

Presentations

East Belfast Community Development Association (EBCDA)

The Chairperson welcomed Mr. M. Briggs, Executive Director, East Belfast Community Development Association (EBCDA), to the meeting.

Mr. Briggs provided the Working Group with background information on the EBCDA and its role within East Belfast including its mission, namely, to provide resources, support and capacity building programmes for community groups that are based upon partnerships, equal opportunities and sustainable outcomes.

He presented the Working Group with an overview of the EBCDA Strategic Plan for 2025-2030, 'People Continue to Build Communities', which included detail on:

- Community Development Adopted from the Community Development National Occupational Standards to enable people to work collectively to bring about positive social change; to enable communities to identify their own needs and actions; take collective action using their strength and resources; develop their confidence, skills and knowledge; challenge unequal power relationships; and promote social justice, equality and inclusion.
- Values The community development process was underpinned by a set of five key values - social justice and equality; community empowerment; collection action; anti-discrimination; and working and learning together.
- Strategic Themes Community Development Support; Community Resource and Finance Support; and Community Health Development Support.

Mr. Briggs provided the Working Group with a breakdown of the EBCDA membership, which included full and associate members. He also provided a breakdown in respect of EBCDA's total income.

He advised that EBCDA managed the East Belfast Network Centre, which was located in the former Templemore Avenue Elementary School building, and included an office base for EBCDA, Dementia Navigators, Engage With Age, uHub Counselling Centre, East Belfast Independent Advice Centre, East Belfast Surestart, Replay Theatre Company, Arts and Business, and conference and meeting space.

During discussion Mr. Briggs answered a range of questions from the Members in relation to the EBCDA membership, volunteering and the challenges currently facing the voluntary sector, Council support and the collaboration within the Network Centre.

The Chairperson thanked Mr. Briggs for his attendance and presentation, and he retired from the meeting.

After discussion, the Working Group noted the information which had been provided.

EastSide Partnership

The Chairperson welcomed Ms. M. Bryans, Chief Executive, and Ms. G. Hamilton, Partnership Manager, representing EastSide Partnership to the meeting.

The representatives presented the Working Group with an update in relation to EastSide Greenways with a focus on the funding which it had recently received through the National Lottery's Climate Action Fund as part of a project to create a climate-resilient Connswater Community Greenway.

Ms. Bryans and Ms. Hamilton provided context to the project, which was to link climate action to the everyday lives and interests of local communities, inspire action, and to influence communities at a regional and national level. She advised that £1.3 million had been awarded over five years and had commenced at the beginning of September. It was reported that the funding would support neighbourhood led projects with the scope to feed into and help shape city-wide and regional agendas, and projects which could be scaled up. The Working Group was then provided with an overview of the Climate Action Fund Partnership model.

The representatives outlined the projects desired outcomes which included to:

- understand the natural environment;
- raise awareness of climate change;
- build capacity within communities;
- develop scalable pilot projects;
- movement building;
- empower communities; and
- influence and inform policy and strategy.

During discussion the representatives answered a range of questions from the Members in relation to the pilot projects, collation of relevant existing data in relation to air and water pollution, biodiversity, EastSide Partnership resources and community and youth engagement.

The Chairperson thanked the representatives for their attendance and presentation, and they retired from the meeting.

After discussion, the Working Group noted the information which had been provided.

Request to Present - Phoenix Education Centre

The Working Group acceded to a request from the Phoenix Education Centre to present to a future meeting an overview of the work it is doing within East Belfast to tackle educational inequality, support young people and families, and provide accessible accredited learning.

Physical Programmes Update

The Working Group considered the undernoted report:

1. <u>Introduction</u>

The Council's Physical Programme covers projects under a range of funding streams including the Capital Programme, the

Leisure Transformation Programme, the Local Investment Fund (LIF), the Belfast Investment Fund (BIF), Social Outcomes Fund (SOF) and the Neighbourhood Regeneration Fund (NRF); in addition, the programme covers projects that the Council is delivering on behalf of other agencies. This report outlines the status of projects under the Physical Programme.

2. Recommendations

Members are asked to:

- Note the physical programme update for East Belfast including recently completed projects at Appendix 1 – Castlereagh Presbyterian Church and Parklands, Knocknagoney Dale - Knocknagoney Park Improvements;
- note the scheduled date regarding the dedicated workshop session facilitated by the consultants on the new crematorium project on Thursday, 18th September 2025. All Members of the AWG and SP&R Committee can attend.

3. Local Investment Fund

LIF is a £9m fixed programme of capital investment in non-council neighbourhood assets, over two tranches: LIF 1 (2012-2015) - £5m total funding pot, allocated across each AWG areas; and LIF 2 (2015 -2019) - £4m allocation with the East being allocated £1.127m under LIF1 and £1.2m under LIF2.

Each LIF project proposal is taken through a Due Diligence process prior to any funding award. The table below outlines funding spend to date for each tranche, at key stages of the delivery process: 22 projects received In Principle support under LIF1 and LIF2, of which 19 have been completed and 1 project is at delivery stage and 1 project is at due diligence stage.

4. Belfast Investment Fund

Members are reminded BIF is a £28m investment fund for regeneration partnership projects, with a minimum £250,000 investment from Council. In East Belfast, 9 projects have received an In-Principle funding commitment under BIF. There are 5 projects on the longer BIF list. Each of the In-Principle projects are taken through a 3-stage approval process, including a rigorous Due Diligence process before any Funding Agreement is approved and put in place. The table below provides a summary of BIF allocated projects i.e. project stage; project title; and the funding allocated.

5. Social Outcomes Fund

SOF is £4m ringfenced capital investment programme with a focus on local community tourism projects. There is one project under SOF for East Belfast - Eastside Visitor Centre – with an In-Principle funding commitment. Similar to BIF, all projects are subject to Due Diligence process prior to any funding award.

6. Neighbourhood Regeneration Fund

The Neighbourhood Regeneration Fund (NRF) is a capital fund with a current overall budget of £10,280,000 to help groups deliver capital projects that will make a real, long-term difference in their communities. The overall NRF allocation for East was £2,351,551 and 4 projects received an In-Principle funding commitment. Each NRF project is taken through a 3-stage approval process, including a rigorous Due Diligence process before any Funding Agreement is approved and put in place. Projects remaining at Stage 2 continue to have the support of a Client Manager for their proposals.

In June 2025, SP&R Committee agreed to hold a dedicated workshop to inform a Strategic Analysis and Options Appraisal on the project. The date of the workshop is now set on Thursday 18th September 2025.
Playground Improvement Programme 25/26	Stage 3 – Committed. Agreed at P&C Committee in May 2025. Playgrounds selected for refurbishment are White Rise, Ohio Street, Roddens Crescent, and Finvoy Street playgrounds. Progressing.

- ii. noted that a dedicated workshop session on the new crematorium project, to be facilitated by the consultants, would be held on Thursday 18th September, 2025, and that all Members of the East Belfast Area Working Group and Strategic Policy and Resources Committee could attend.

Employability and Skills (Verbal Update)

The Labour Market Partnership Co-ordinator provided the Working Group with an update on the forthcoming Council roadshows which would offer information on the Employment Academies that were open for recruitment such as classroom assistants, transport, business services, childcare, health and social care, beauty and construction.

He reported that a series of roadshows would be held across the city, including in East Belfast on Tuesday 9th September, 2025, in the Skainos Centre, Newtownards Road, and would be supported by the Gateway to Choice service to provide information, advice and guidance.

He drew Members attention to the Employability and Skills Network, which provided further information on the employability and skills initiatives, programmes and

opportunities that were available across the city, and encouraged Members to register on to the Network.

The Labour Market Partnership Co-ordinator highlighted to the Working Group that Harland and Wolff shipyard employees had recently completed an upskilling welding academy, which was essential to fulfil a new contract, and advised that there was work being undertaken to carry out a maritime and shipbuilding skills audit, which would focus on both the Council's plans in relation to the sector and the regional plans for the sector going forward.

The Working Group noted the Employability and Skills update provided.
