The Chief Executive reported that the High Sheriff (Councillor McCausland) had received a letter from the Northern Ireland Office inviting him, in accordance with normal practice, to submit to the Secretary of State the names of three people suitable for appointment to the Office of High Sheriff of the City for the year 1998. The Chief Executive advised the Council that the letter indicated that the Secretary of State

wished, so far as possible, to ensure that persons appointed to such posts were representative of the Northern Ireland community as a whole. The letter also pointed out that, in the past, women and members of the minority community had been under-represented in the Office.

The Council discussed the matter and agreed that it would submit one name only.

Accordingly, the Lord Mayor invited nominations in respect of the name to be submitted to the Northern Ireland Office for appointment to the Office of High Sheriff of Belfast for 1998.

Councillor J. Clarke was proposed by Councillor D. Browne and seconded by Councillor Crooks.

As no other nominations were received, it was accordingly,

Resolved - That Councillor Jim Clarke be and he is hereby nominated to the Northern Ireland Office for appointment to the Office of High Sheriff of the City for 1998.
