1.0	Purpose of Report/Summary of Main Issues																																	
1.1	<p>The purpose of this report is to outline the funding recommendations of the Area Based Working Groups to organisations which will deliver Summer Scheme activities for children with additional needs.</p> <p>Officers attended each of the Area Based Working Groups and presented reports explaining the detailed engagement with the sector and recommended providers in each area. The recommendations were agreed in the north, south and west Area Based Working Groups, the east Area Based Working Group did not have a quorum and this report seeks to ensure appropriate elected member approval to enable Letters of Offer to be issued.</p>

2.1	Members are asked to approve the recommendations for summer schemes for children with additional needs summarised in table 3.3 below across north, south, east and west Belfast.

	Background information																																	
3.1	A report proposing enhanced summer scheme provision was brought to the February 2024 meeting of the People and Communities Committee and an amount of £80,000 was agreed to support provision across each of the four areas of the city with decisions to be approved through the Area Based Working Groups.																																	
3.2	Officers attended the February/March Area Based Working Groups to discuss any potential models suggested by elected members and to engage around local organisations which may be in a position to enhance provision over the summer period. Officers then engaged with the sector and presented recommendations to the May/June Area Based Working Groups.																																	
3.3	<p>The table below represents the approved providers from the North, West and South Area Working Groups.
