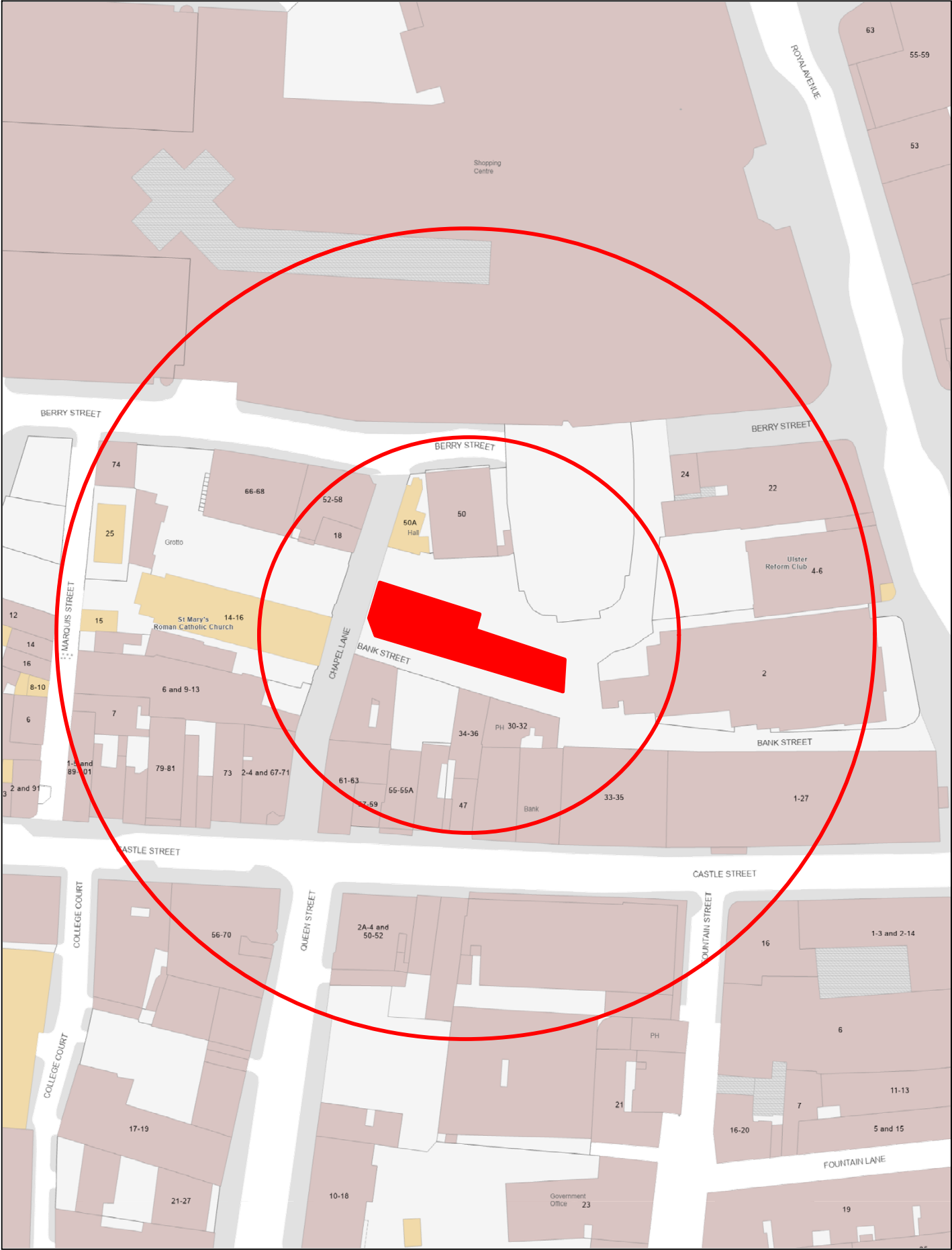

1.0	Purpose of Report
1.1	To consider a request from Mr Henry Downey to permit the planned musical entertainment at Bank Square to run beyond 11.00pm on up to eight nights during the Fleadh Cheoil na hEireann from Sunday 2 August to Sunday 9 August 2026.
2.0	Recommendations
2.1	Taking into account the information presented, and any representations made in respect of the request to extend the hours of entertainment, Members are recommended to agree that entertainment should be permitted to take place beyond the standard hours of licence to 1.00 am on all eight nights of the Fleadh subject to all technical requirements being met. Alternatively, Members could: 1. Agree that only on specified nights will entertainment be permitted to take place beyond the standard hours of licence to 1.00 am and that the other requested nights be permitted to take place to an earlier specified extended hour; or 2. Refuse to extend hours on any night requested.
3.0	Main Report
	<u>Key Issues</u>
3.1	Bank Square has a 7-Day Annual Outdoor Entertainments Licence and a 7-Day Annual Indoor Entertainments Licence for a Marquee, and both have been used to hold events in the past. The Licence is held by the Department of Communities, Mr Gary Hammond, and is transferred to Henry Downey for the duration of the Fleadh.
3.2	A Site Location Map is attached as Appendix 1.
3.3	The days and standard hours during which entertainment may be provided both outdoors and in a marquee are Monday to Sunday from 11.30 am to 11.00 pm.
3.4	In addition, the following Special Conditions are attached to both the Marquee and Outdoor Entertainments Licences: • Maximum numbers will be agreed at the discretion of the Building Control Service and will vary depending upon individual concert set up proposals. • Prior to any event taking place the promoters are required to demonstrate evidence of early consultation and have in place a robust system of dealing with any complaints, which has been agreed in advance with the Council. • Any requests to provide entertainment later than 11.00 pm must be considered by the Licensing Committee and therefore must be made at least 3 months in advance of the proposed event. • Should an application to provide entertainment beyond 11.00 pm be granted and the Council then receive a significant number of complaints regarding noise or the complaint is of such significant impact, authority is granted to the Director of Planning and Building Control, in consultation with the City Solicitor, to reduce the finishing time for any subsequent nights of the event, in which case the promoter will be required to make contingency arrangements.

3.5	Therefore, this request to provide entertainment later than 11.00 pm must be considered by the Licensing Committee.
3.6	As this is not an application to vary the terms of the Outdoor licence, but a request for Council's permission to extend the hours under an existing Licence Condition, there is no requirement for public advertisement in this case.
3.7	The event organiser has indicated that outdoor music events are scheduled for the following nights, Sunday 2, Monday 3, Tuesday 4, Wednesday 5, Thursday 6, Friday 7, Saturday 8 and Sunday 9 August 2026. The request is to provide entertainment to 1.00 am on all eight nights.
3.8	<u>Rationale for extended hours:</u> A rationale for extended hours beyond 11.00 pm has been provided by the event organiser and is attached as Appendix 2.
3.9	A representative of the event organiser has been invited to attend your meeting.
3.10	<u>PSNI:</u> The Police have been contacted by the Service in relation to the event, however, a response has not yet been received.
3.11	Should Members be minded to approve the extended hours requested, this should be subject to a satisfactory response from the PSNI on the matter.
3.12	<u>Health, safety and welfare issues:</u> Officers have engaged with the event organisers and colleagues in the Fleadh events team in relation to the events and will participate in pre-event meetings.
3.13	An Event Management Plan for the Fleadh has been received and is being evaluated by the Service and shared with other colleagues.
3.14	<u>Noise issues:</u> A significant consideration for Environmental Protection Unit (EPU) will be the proposal to provide outdoor entertainment after 11.00 pm. Members are reminded that the Clean Neighbourhoods and Environment Act (Northern Ireland) 2011 gives councils additional powers in relation to entertainment noise after 11.00 pm.
3.15	The noise mitigation strategy will be discussed at the pre-event meetings.
3.16	The event organisers will be required to engage with an acoustic consultant and requested to document a noise mitigation strategy for each night of entertainment. The purpose of the strategy will be to demonstrate that noise from the event will not cause unreasonable disturbance to commercial and residential premises. Once received by the Service this strategy will be provided to EPU for appraisal.
3.17	The organisers have produced a neighbour pre-notification letter containing a nominated event organiser contact that that residents and businesses may refer concerns or make complaints to. The extent of the letter's distribution, which will take place prior to the event, will be agreed with the event organiser by the Service in consultation with EPU officers.
3.18	The event organisers will be reminded of the standard licence condition that receipt of significant complaints may lead to further late nights being curtailed. However, it can be impracticable during the festival to curtail further nights at short notice, and as complaints are not all received on the nights that are the subject of the complaint a full picture does not emerge until all complaints are collated, by which time the events can be concluded.

4.0	Financial and Resource Implications None. Officers will carry out inspections before and during the events which will be catered for within existing Service budgets.
5.0	Equality and Good Relations Implications / Rural Needs Assessment There are no issues associated with this report.

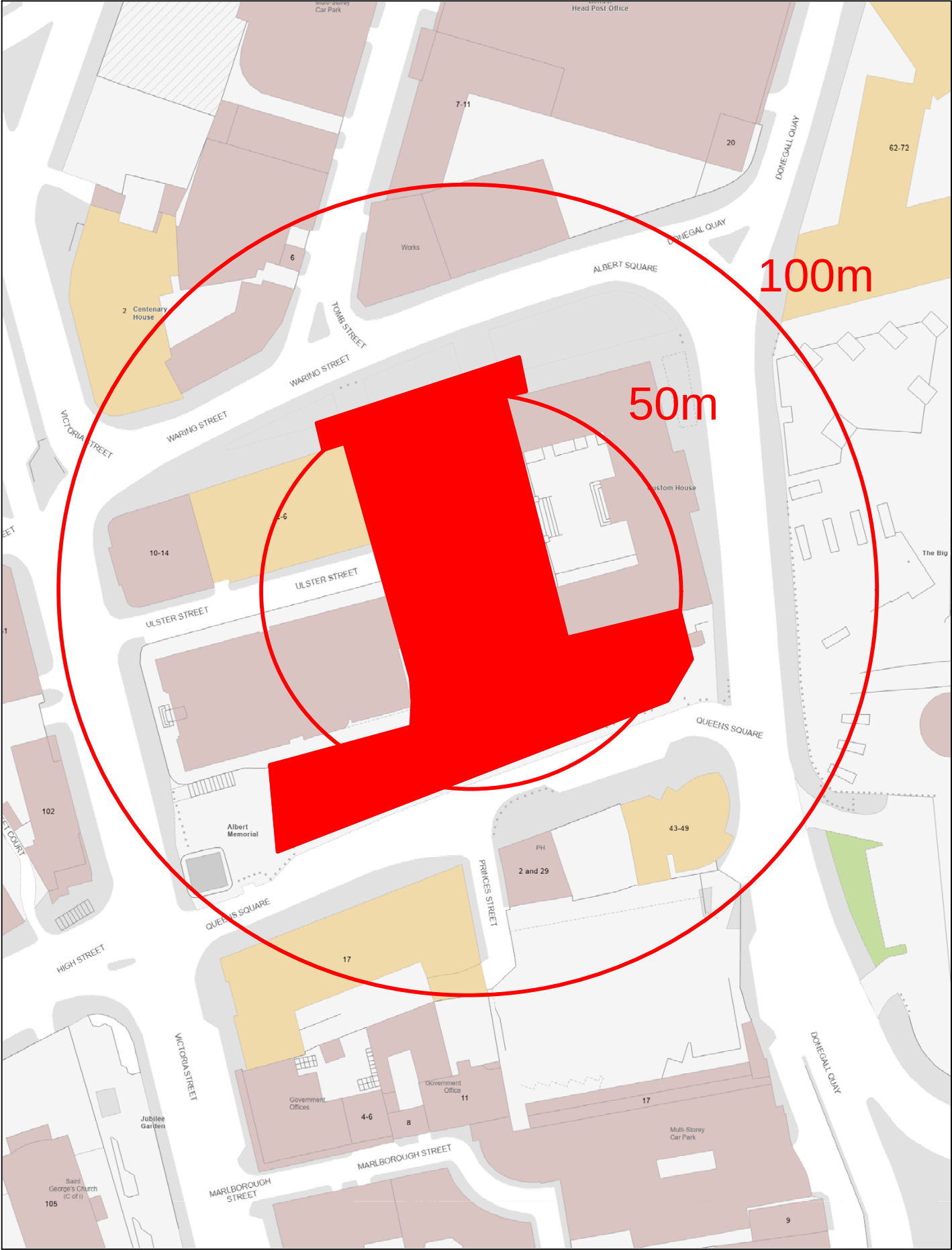

1.1	To consider a request from Belsonic Limited to permit the planned outdoor musical entertainment to run beyond 11.00 pm at Custom House Square on up to three nights during Fleadh Cheoil na hEireann. Two events are associated with the Fleadh, one is the CHSQ series with Lush Classical.
2.0	Recommendations
2.1	Taking into account the information presented, and any representations made it is recommended that Members agree that entertainment should be permitted to take place beyond the standard hours of licence to 1.00 am on Thursday 6, Friday 7 and Saturday 8 August 2026, subject to all technical requirements being met. Alternatively, Members could: a) Agree that only on specified nights will entertainment be permitted to take place beyond the standard hours of licence to 1.00 am and that the other requested nights be permitted to take place to an earlier specified extended hour; or b) Refuse to extend hours on any night requested.
3.0	Main Report
	<u>Key Issues</u>
3.1	Custom House Square has a 7-Day Annual Outdoor Entertainments Licence and a 7-Day Annual Indoor Entertainments Licence for a Marquee, and both have been used to hold events in the past. The Licence held by the Department of Communities, Mr Gary Hammond, is transferred to Belsonic Limited for the duration of their event.
3.2	A Site Location Map is attached as Appendix 1.
3.3	The days and standard hours during which entertainment may be provided both outdoors and in a marquee are Monday to Sunday from 11.30 am to 11.00 pm.
3.4	In addition, the following Special Conditions are attached to both the Marquee and Outdoor Entertainments Licences: • Maximum numbers will be agreed at the discretion of the Building Control Service and will vary depending upon individual concert set up proposals. • Prior to any event taking place the promoters are required to demonstrate evidence of early consultation and have in place a robust system of dealing with any complaints, which has been agreed in advance with the Council. • Any requests to provide entertainment later than 11.00 pm must be considered by the Licensing Committee and therefore must be made at least 3 months in advance of the proposed event. • Should an application to provide entertainment beyond 11.00 pm be granted and the Council then receive a significant number of complaints regarding noise or the complaint is of such significant impact, authority is granted to the Director of Planning and Building Control, in consultation with the City Solicitor, to reduce the

3.7	The event organiser has indicated that outdoor music events are scheduled for the following nights, Thursday 6, Friday 7 and Saturday 8 August 2026. The request is to provide entertainment to 1.00 am on these three nights.
3.8	<u>Rationale for extended hours:</u> A rationale for extended hours beyond 11.00 pm has been provided by the event organiser and is attached as Appendix 2.
3.9	A representative of the event organiser has been invited to attend your meeting.

3.11	Should Members be minded to approve the extended hours requested, this should be subject to a satisfactory response from the PSNI on the matter.
3.12	<u>Health, safety and welfare issues:</u> Officers have engaged with the event organisers and colleagues in the Fleadh events team in relation to the events and will participate in pre-event meetings.
3.13	An Event Management Plan has been received and is being evaluated by the Service and shared with other colleagues.
3.14	<u>Noise issues:</u> A significant consideration for Environmental Protection Unit (EPU) will be the proposal to provide outdoor entertainment after 11.00 pm. 3.18	The event organisers will be reminded of the standard licence condition that receipt of significant complaints may lead to further late nights being curtailed. However, it can be impracticable during the event to curtail further nights at short notice, and as complaints are

CUSTOM HOUSE SQUARE - BELFAST FLEADH

Rationale for extended hours

This year, the annual CHSQ music festival was scheduled to run from Sat 8th August - Tues 1st September. In response to the Belfast Fleadh, we are opening Custom House Square on Thursday 6th August, Friday 9th August and extending our hours of operation on Saturday 8th August (6pm-1am) which will further enhance the Fleadh offering.

During Thurs 6th and Fri 7th Aug we intend to open the custom house site from 2pm until potentially 1am (dependent on demand), we will also be extending the hours of operation on Saturday 8th August for the Lush! Classical Concert to 1am. This provides an additional space for five thousand people in Belfast city Centre. Bar, food, toilet facilities and medical provision for five thousand people will be during our operational times.

We will not be selling tickets or charging into Custom House during these two dates, however we have asked Cancer Fund For Children to be present for donations for entry. The Lush! Classical event on Saturday 8th August is ticketed, as per normal CHSQ events.

We are asking for an extension to our entertainment hours on Thursday 6th, Friday 7th and Sat 8th August to 1am. This is to provide a better service for Fleadh guests in that we offer all the additional services noted. After discussions with Belfast City Council, we feel that guests should be kept on site rather than egress happening as normal at 10:45pm, which may overburden the city centre.

Should our extension be granted, Entertainment will be provided between the hours of 2pm-1am with a mixture of bands, DJ and solo performers on Thursday 6th and Friday 7th August, with Saturday 8th August operating from 5pm-1am. We note that this may cause inconvenience to nearby residents and offer mitigations in our event management plan including security and reduced volume.

3.1	St Anne's Cathedral is within the road closure pedestrianised area for Fleadh Cheoil na hEireann.						
3.2	The entertainments licence applied for is to facilitate the provision of outdoor entertainment to the North side of St Anne's Cathedral site, the location of the Fleadh Cheoil food and drink market.						
3.3	The applicant wishes to host entertainment in this outdoor area in line with the Fleadh's traditional music entertainment offering.						

3.4	The applicant has requested that outdoor musical entertainment be permitted beyond the standard hour of 11.00pm to 12:00am on all nights of Fleadh Cheoil 2-9 August 2026.

3.12	<u>Noise issues</u> The applicant proposes to provide non-amplified musical entertainment within the outdoor area in the form of traditional music live bands during the Fleadh.
3.13	As entertainment is proposed to be provided beyond the standard finishing time for outdoor musical entertainment to 12:00 am, if granted, a special condition will be added to the licence relating to the sole provision of non-amplified musical entertainment.

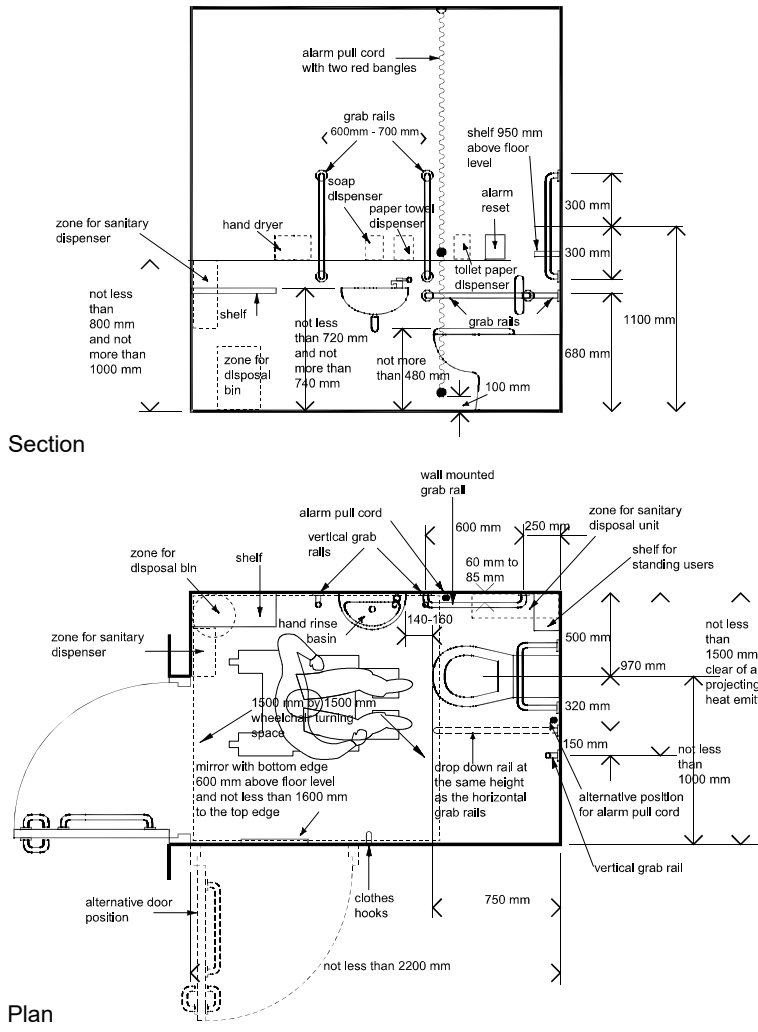
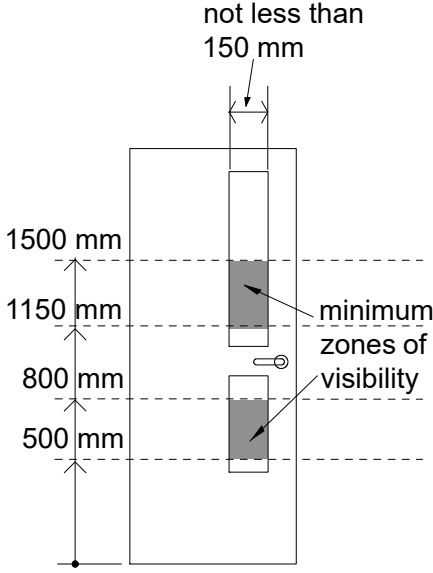
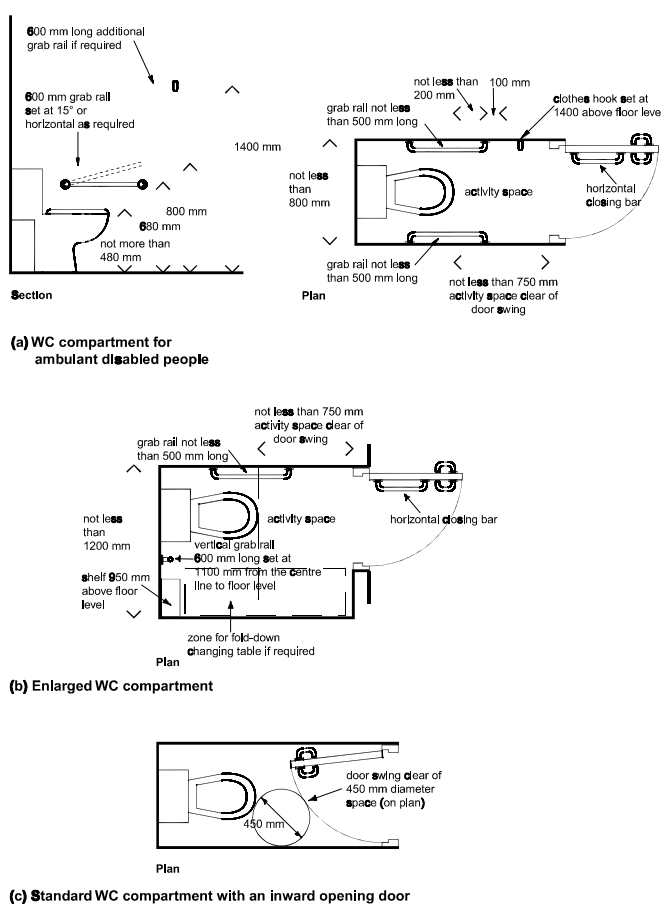
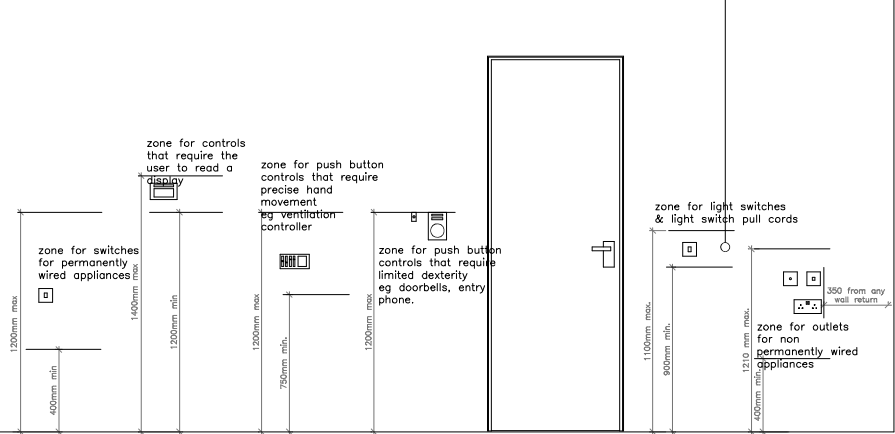


Diagram 6.3 Watercloset Compartments

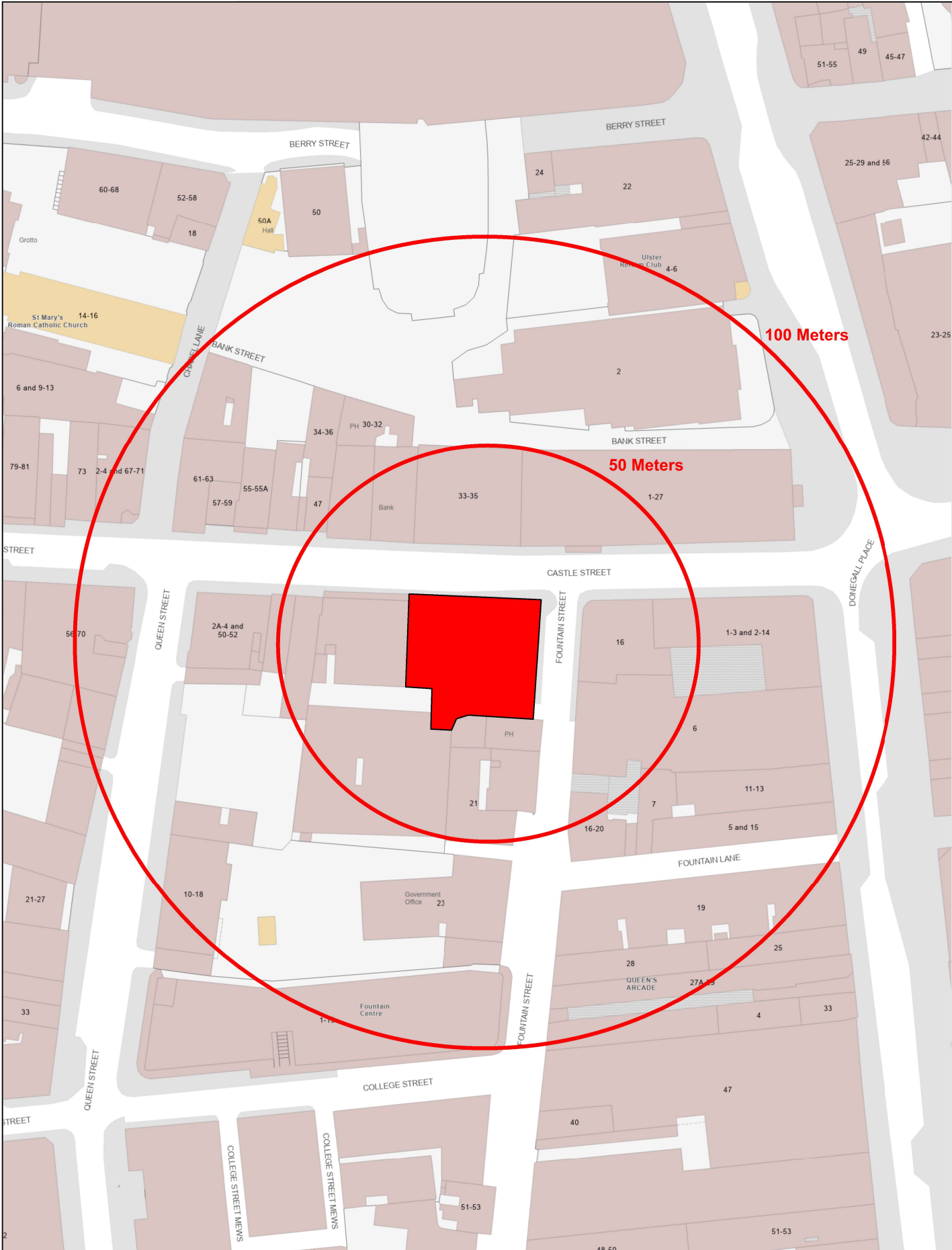

Members are reminded that all applications for the grant of Outdoor Entertainments Licences must be brought before Committee for consideration. This report is to consider a request from Power Pictures Limited for the grant of a 14-Day Occasional Outdoor Entertainments Licence for the former Norwich Union House site, accommodating a temporary venue for TV production, based on the Council’s Standard Conditions to provide outdoor musical entertainment. The request by the applicant also seeks permission for planned entertainment to run beyond 11.00pm on up to 4 nights in the outdoor area, and also within a marquee located on the site. 2.0	Recommendations			
2.1	Taking into account the information presented and any representations made Members are recommended to approve the application for the grant of a 14-Day Occasional Outdoor Entertainments Licence, subject to any special conditions considered necessary by officers and to all technical requirements being met. Should the licence be granted, it is recommended that Members agree to extend the hours of entertainment to 11.30pm on 4 consecutive days between Thursday 6th - Sunday 9th August 2026 inclusive. Alternatively, Members could agree that musical entertainment is permitted to take place to 11.30pm on certain specified nights during that period, or refuse to extend the hours as requested. In relation to the marquee, Members are recommended to approve the request to extend the hours of entertainment to 11.30pm on 4 consecutive days between Thursday 6th - Sunday 9th August 2026 inclusive, subject to all technical requirements being met.			

	Alternatively, Members could agree that musical entertainment is permitted to take place to 11.30pm on certain specified nights during that period, or refuse to extend the hours as requested. Should Members be minded to refuse the application grant of a 14-Day Occasional Outdoor Entertainments Licence, or reuse the request to extend hours of entertainment within the marquee, or special conditions are attached to the licence to which the applicant does not consent, then the applicant may appeal the Council's decision within 21 days of notification of that decision to the County Court. In the case that the applicant subsequently decides to appeal, entertainment may not be provided until any such appeal is determined. Due to time constraints, it is unlikely that an appeal could be concluded in time for entertainment to be provided during Fleadh 2026.
3.0	Main Report
	<u>Key Issues</u> 3.1 The applicant is an independent production company commissioned by Irish language television channel, TG4, with experience in broadcasting live coverage of Fleadh Cheoil na hÉireann events 3.2 The applicant has submitted a 14-Day Occasional Outdoor Entertainments Licence for the former Norwich Union House site located at 24-40 Castle Street. The site is within the road closure pedestrianised area for Fleadh Cheoil na hÉireann. 3.3 The applicant has also proposed to provide entertainment within the new outdoor area beyond 11.00pm. The day and hours proposed are: - Thursday 6th, Friday 7th, Saturday 8th and Sunday 9th August: 11.30 am to 11.30 pm All remaining days of the 14-Day Occasional Licence are to remain as standard hours: 3.4 11.30 am to 11.00 pm 3.5 There will be no entertainment provided on the site on any of the other days of Fleadh Cheoil. 3.6 There will be minimal amplification of music in the outdoor area for the benefit of a small crowd attending. This will be intermittent as the bulk of the performances take place within the marquee and the priority with sound is that which is broadcast. 3.7 In addition, the applicant has requested permission to provide entertainment beyond 11.00pm within a marquee to be located at the site. This particular structure is subject to the conditions of a Marquee Entertainments Licence granted for the site. The day and hours proposed are: - Thursday 6th, Friday 7th, Saturday 8th and Sunday 9th August: 11.30 am to 11.30 pm the following morning 3.8 There will be amplified entertainment in the marquee. 3.9 The following Special Conditions are attached to both the Marquee and Outdoor Entertainments Licences:

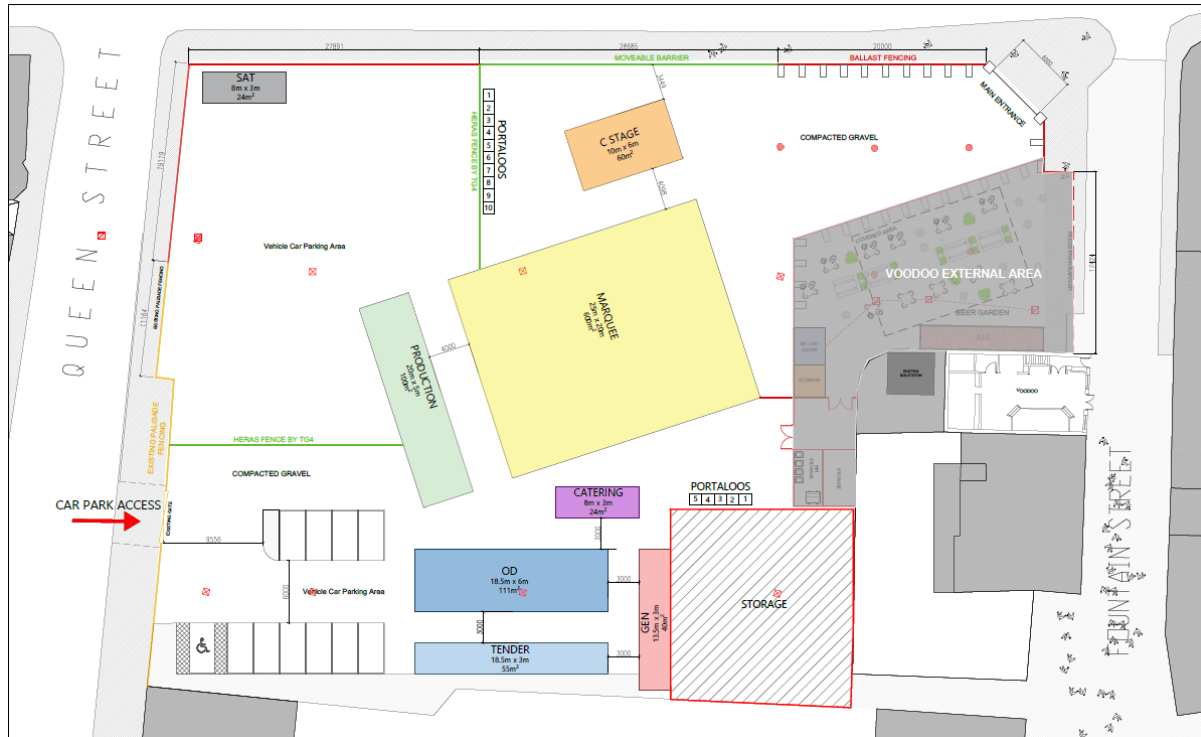
	• Maximum numbers will be agreed at the discretion of the Building Control Service and will vary depending upon individual concert set up proposals. • Prior to any event taking place the promoters are required to demonstrate evidence of early consultation and have in place a robust system of dealing with any complaints, which has been agreed in advance with the Council. • Any requests to provide entertainment later than 11.00 pm must be considered by the Licensing Committee and therefore must be made at least 3 months in advance of the proposed event. • Should an application to provide entertainment beyond 11.00 pm be granted and the Council then receive a significant number of complaints regarding noise or the complaint is of such significant impact, authority is granted to the Director of Planning and Building Control, in consultation with the City Solicitor, to reduce the finishing time for any subsequent nights of the event, in which case the promoter will be required to make contingency arrangements.
3.10	Therefore, this request to provide entertainment later than 11.00 pm must be considered by the Licensing Committee.
3.11	As this is not an application to vary the terms of the Indoor (Marquee) licence, but a request for Council's permission to extend the hours under an existing Licence Condition (if approved) there is no requirement for public advertisement in this case.
3.12	<u>Rationale for extended hours:</u> The applicant has identified the request for extended hours beyond 11.00 pm has been to align coverage of performances with TV scheduling requirements.
3.13	The applicant has been invited to attend your meeting.
3.14	<u>PSNI:</u> The Police have been contacted by the Service in relation to the event, however, a response has not yet been received. We will update Committee at your meeting.
3.15	Should Members be minded to approve the extended hours requested, this should be subject to a satisfactory response from the PSNI on the matter.
3.16	<u>Health, safety and welfare issues:</u> Officers have engaged with the event organisers and colleagues in the Fleadh events team in relation to the events and will participate in pre-event meetings.
3.17	An Event Management Plan for the entertainment offerings at 24-40 Castle Street has been received and is being evaluated by the Service and shared with other colleagues.
3.18	<u>Noise issues:</u> A significant consideration for Environmental Protection Unit (EPU) will be the proposal to provide outdoor entertainment after 11.00 pm. Members are reminded that the Clean Neighbourhoods and Environment Act (Northern Ireland) 2011 gives councils additional powers in relation to entertainment noise after 11.00 pm.
3.19	Outdoor performances will have minimal amplification of music. It is a requirement of the applicant that the level of noise generated in the outdoor space does not impact on the broadcast of performances filmed within the marquee located on site. An acoustic report has not been sought in this instance for the outdoor application.
3.20	Amplified music will be provided within the marquee located on site. Amplification of music is to solely cater for patrons within the marquee and recording of performances for broadcast

	on TV. The level of amplification is therefore not considered likely to give rise to noise disturbance to residents in the area. An acoustic report has not been sought in this instance.
4.0	Financial and Resource Implications None. Officers will carry out inspections before and during the events which will be catered for within existing Service budgets.
5.0	Equality and Good Relations Implications/Rural Needs Assessment There are no issues associated with this report.
