**Domestic Violence, Sexual Violence  
and Human Trafficking**

The Deputy Lord Mayor (Councillor Kelly) to move:

“That this Council is concerned at the absence of a co-ordinated approach to address the increasing prevalence of violence against women in Belfast and throughout Northern Ireland and, accordingly:

- Welcomes the ‘Making the Grade’ report produced by the End Violence Against Women Coalition;
- Recognises the level of domestic violence and sexual violence in Northern Ireland, for example, that 20% of murders in 2006/07 had a domestic motivation, that 30% of all cases of domestic violence start during pregnancy and that conviction rates for rape have gone down while the number of recorded rapes has increased;
- Acknowledges the Women’s Aid ‘Beyond Borders’ report which demolished the myth that trafficking does not happen within Northern Ireland;
- Notes the call in the Making the Grade report for an integrated strategy, across all authorities, to tackle violence against women;
- Commits itself to implementing recommendations of the ‘Making the Grade’ report applicable to the Council; and
- Calls for the actions on the recommendations by relevant departments and authorities.”

The Members of Belfast City Council are hereby summoned to attend the meeting.
