

The Chief Executive submitted the summons convening the meeting.

#### Apologies

An apology was reported on behalf of Councillor McAllister.

#### Declarations of Interest

Councillor Mulholland declared an interest in relation to the item contained within the minutes of the City Growth and Regeneration Committee, under the heading "A City Imagining Investment Programme – Cultural Multi-Annual Grants", on the basis that she was employed by the Oh Yeah Music Centre and a family member was a director of Prime Cut Productions, both of which had secured funding, and left the Chamber whilst the matter was being discussed.

The High Sheriff (Councillor Verner) declared an interest in relation to the item contained within the minutes of the City Growth and Regeneration Committee, under the heading "A City Imagining Investment Programme – Cultural Multi-Annual Grants", in that she was employed by the Greater Shankill Partnership, which had applied for funding, and left the Chamber whilst the matter was under consideration.

Alderman Haire declared an interest in relation to the item contained within the minutes of the Strategic Policy and Resources Committee, under the heading "George Telford Memorial Grand Lodge Centenary Dinner", on the basis that he had attended the event, and left the Chamber when the matter was raised.

Councillor Graham declared an interest in relation to the item contained within the minutes of the Strategic Policy and Resources Committee, under the heading “George Telford Memorial Grand Lodge Centenary Dinner”, in that that he was a past Grand Master of that Lodge, and left the Chamber when the matter was raised.

Councillor Long pointed out that his wife was the Assembly’s Justice Minister and that, should any matters of a pecuniary nature be raised which fell within the remit of the Department of Justice, he would leave the Chamber. However, as no matters were raised, he was not required to do so.

Councillor Whyte declared an interest in relation to the item contained within the minutes of the Strategic Policy and Resources Committee under the heading “Belfast Healthy Cities, in that his mother was employed by that organisation. However, as it did not become the subject of discussion, he was not required to leave the Chamber.

Councillor Canavan declared an interest in relation to the item contained within the minutes of the City Growth and Regeneration Committee, under the heading “A City Imagining Investment Programme – Cultural Multi-Annual Grants”, on the basis that she was a member of the Greater Shankill Partnership Board, and left the Chamber whilst the matter was being discussed.

Councillor McMullan declared an interest in relation to the motion on Compass Counselling, in that his wife worked for a rival organisation, and left the Chamber whilst it was under consideration.

**Official Announcements**

The Lord Mayor, on behalf of the Council, congratulated local MMA fighter Leah McCourt on being the first woman to headline a Bellator Europe event in Dublin and on defeating her opponent.

Councillor Mulholland thanked Ms. Catherine Toolan, who would shortly be leaving her post as Chief Executive of the Belfast Waterfront and Ulster Hall to take up an appointment as Managing Director of the Guinness Storehouse in Dublin, and wished her well for the future.

Councillor Donnelly paid tribute to former Belfast Sinn Féin Councillor, Mrs. Lily Fitzsimons, who had died recently and extended his condolences to her family.

Councillor Graham thanked the Lord Mayor for visiting the Suffolk Community Garden earlier in the day to view a number of projects being delivered there.

**Requests to Address the Council**

**2020 EUBC Schoolboys and Schoolgirls  
European Boxing Championships**

The Chief Executive informed the Council that a request had been received from Mr. L. Corr, Belfast Boxing Development Officer, to address the Council in relation to the decision of the Strategic Policy and Resources Committee of 21st February, under the heading “Financial Reporting – Quarter 3 2019/20”, not to provide additional support of £100k towards the hosting of the 2020 EUBC Schoolboys and Schoolgirls European Boxing Championships.

The Council approved the request and Mr. Corr, together with Mr. C. Toland, Ulster Boxing Council Secretary, and Mr. S. O’Hare, Ulster Boxing Operations Manager, were welcomed to the meeting.

Mr. Corr referred to the success of the recent bid to host the 2020 EUBC Schoolboys and Schoolgirls European Boxing Championships in Belfast and pointed out that it would be the first major amateur boxing event to be held in the City since 2001. The Championships, which would run from 7th June till 11th July, would be held in Queen’s University’s Physical Education Centre and would attract around 750 competitors. It was estimated that 10,000 people would visit the City over the course of the Championships and that 13,500 bed nights and between £1.5 million and £2 million would be generated. The event would also be streamed across a number of media platforms.

In terms of other funding sources, he pointed out that Sport Ireland, the Department for Communities and Tourism NI, had been approached but had yet to respond. Mr. Corr concluded by highlighting the short timeframe which existed to allow for preparations to begin in earnest and by stressing the need for the Council to provide the additional support for the event.

Mr. Toland pointed out that the Council’s Boxing Strategy had played a central role in promoting boxing across the City and referred to the marked increase in the number of boxing clubs since its implementation. He stressed that the hosting of the 2020 EUBC Schoolboys and Schoolgirls European Boxing Championships would build upon that work and that additional support from the Council was essential to ensure their success.

The Lord Mayor thanked the boxing representatives for their presentation.

The Council noted the information which had been provided and that it would have an opportunity to discuss the issue later in the meeting.

**Relationship and Sexual Education**

The Council was informed that a request had been received from Mr J. J. McGrady, Chair of the Belfast Youth Forum, to allow a group of young people from the Youth Forum to address the Council in advance of Councillor Mulholland's motion on Relationship and Sexual Education.

The Council approved the request and Mr. C. Fay, Mr. B. Matchett, and Ms. S. McCullough were welcomed to the meeting.

Ms. McCullough provided a brief overview of the work of the Youth Forum and drew the Members' attention to its recent research project, entitled "Any Use?", which had examined the issue of Relationship and Sexual Education in schools. The project, which had involved Queen's University and Common Youth, had been undertaken in response to concerns which had been expressed by many young people around the poor quality and content of the relationship and sexual education being provided by schools and had produced strong evidence to support those concerns.

Mr. Fay reported that almost 800 young people across Belfast had taken part in the Youth Forum's research project. Respondents had used terms such as basic, unhelpful, inconsistent, biased and almost non-existent to describe the Relationship and Sexual Education which they had received. He pointed out that young people were not asking for a school's ethos or the views of parents to be ignored but for the opinions of young people on their relationship and sexual education to be given equal consideration.

Mr. Matchett pointed out that the motion being presented later in the meeting called upon the Council to support the three recommendations resulting from the "Any Use?" report and stressed that, if passed, it would send a positive message to those involved in curriculum and educational policy making, in the context of addressing young people's relationship and sexual education.

The Youth Forum representatives were thanked by the Lord Mayor.

The Council noted the information which had been provided and that it would have an opportunity to discuss the issue later in the meeting.

**Compass Counselling**

The Chief Executive informed the Council that a request had been received from Ms. M. McDermott, a Director of Compass Counselling, to address the Council in advance of the motion on Compass Counselling being proposed by Councillor Matt Collins.

The Council acceded to the request and Ms. McDermott, together with Ms. S. Irwin and Ms. P. Whelan, were welcomed to the meeting.

Ms. McDermott informed the Council that Compass Counselling had been established four years ago in response to an unmet need to provide support to communities in North and West Belfast affected by high levels of social deprivation,

addiction, suicide and self-harm. The organisation provided professional counselling, holistic therapies and bespoke educational/informative training programmes to community groups, professional and statutory agencies and those experiencing mental health issues and life-changing events.

She highlighted the fact that Compass Counselling required immediate investment to ensure its survival and urged the Council to support its call for the Minister of Health to demonstrate his commitment to tackling mental health, as outlined within the New Decade, New Approach deal, by saving it from closure.

Ms. Irwin reported that Compass Counselling had provided around 900 sessions per year since it had opened. The number of staff employed within the organisation had increased from three to twelve over the past four years and currently comprised Directors, clinical supervisors, accredited counsellors, holistic therapists, positive psychology mentors, nutritional advisors and final year placement counsellors. Staff worked in a voluntary capacity and the organisation was self-funding, mainly through fundraising and contributions. She pointed out that the increased demand for the organisation's services had grown to the extent that it now required significant support to continue to operate.

Ms. Whelan outlined the valuable support which she had obtained from Compass Counselling during a difficult period in her life and confirmed that she was now a volunteer in the organisation and was training to become a counsellor. She too highlighted the need for the Council and others to do everything within their power to save this vital service.

The deputation was thanked by the Lord Mayor.

The Council noted the information which had been provided and that it would have an opportunity to discuss the issue later in the meeting.

On that basis, the request to fund Compass Counselling would need to be referred to the Strategic Policy and Resources Committee for consideration.

Accordingly, Councillor Murphy’s amendment was revised to the effect that the Council agrees:

- to provide additional support of £100k to the Ulster Boxing Council to host the 2020 EUBC Schoolboys and Schoolgirls European Boxing Championships from 7th June till 11th July; and
- that the matter of the allocation of £20k to Compass Counselling be referred to the next monthly meeting of the Strategic Policy and Resources Committee for consideration.

On a vote by show of hands twenty-three Members voted for the amendment and thirty against and it was declared lost.

The Council agrees to scope future investment and a feasibility study for the entire Zoo site, including the Floral Hall, Belfast Castle and the Belfast Hills. This will be done in conjunction with leading experts, key stakeholders and public consultation and engagement.

Additionally, we seek an all-Party meeting with the Minister for the Economy to push for Central Government funding for the redevelopment of the Zoo site.”

At the request of Councillor Whyte, the proposer agreed to amend his motion to allow for the replacement of the word “redevelopment” with the word “regeneration” in the final paragraph.

“This Council reaffirms its support for the Belfast Zoo and its staff and its long term sustainability and future investment. We also commit ourselves to a moral and compassionate approach to the animals housed in the Zoo and commit to ensure a future use that is conservation centred, educational, looking specifically at ecology, and economically modelled that it ends the burden on the Belfast ratepayer.

The Council agrees to scope future investment and a feasibility study for the entire Zoo site, including the Floral Hall, Belfast Castle and the Belfast Hills. This will be done in conjunction with leading experts, key stakeholders and public consultation and engagement.

Additionally, we seek an all-Party meeting with the Minister for the Economy and the Minister for Communities to push for Central Government funding for the regeneration of the Zoo site.”

The Council notes the 59 recommendations listed in the Commissioner for Older People’s ‘Home Truths’ report and calls upon the Minister of Health to ensure that the recommendations are adopted for implementation as soon as possible. It notes also the work carried out on behalf of the Department of Health by CPEA Ltd. into the care of older people in residential homes.

Accordingly, the Council welcomes this work and calls upon the Minister to publish in full the CPEA Ltd. report as soon as possible.”

**Review of Hate Crime Legislation in Northern Ireland –  
Inclusion of Mysogyny as a Standalone Offence**

In accordance with notice on the agenda, Councillor Groogan proposed:

“This Council recognises the impact of misogyny and transmisogyny on those affected by it, as well as the role these attitudes play in a variety of crimes, including harassment, assault, sexual assault and hate crimes, and on the career choices and personal lives of women, girls and non-binary people.

The Council supports also the Raise Your Voice Project, which tackles sexual harassment and sexual violence across Northern Ireland, by placing posters in all Council properties to raise awareness of the project.”

The motion was seconded by the High Sheriff (Councillor Verner).

The proposer agreed, at the request of Councillor Ferguson, to amend her motion to provide for the addition of the following wording after the final paragraph:

“The Council will invite representatives of the Raise Your Voice project to deliver training for Members on the realities facing victims of sexual harassment and violence and how we can best equip ourselves to assist them in our role as Elected Members.”

### **Declarations of Interest**

Councillor McKeown declared an interest in respect of the motion on the St. Patrick's Day Event in that he was employed by the Public Health Agency and left the meeting whilst this item was under discussion.

### **Request to Address the Council**

The Chief Executive informed the Council that a request had been received from Ms. J. Cummings, Flybe employee, Mr. G. Brash, from Unite the Union, and Mr. C. Robb, British Airline Pilots Association, to address the Council in advance of the motion on Flybe Airline, which was being proposed by the Lord Mayor, Councillor D. Baker.

The Council approved the request and the deputation was welcomed to the meeting.

Mr. Brash stated that, from a Union prospective, the Flybe collapse had massive repercussions on Flybe staff and other workers throughout the supply chain. He referred to the impact on the Northern Ireland economy and that the Union was calling for the

airport to come back into public service authority and asking for Councillors to lobby MLAs and local politicians to secure funding to allow that to happen. He referred to the cherry picking of the routes by other airlines and how this would not secure jobs and that an airline needed to be based at the City airport for this to happen.

Ms. Jennings advised that she had worked at Flybe for 19 years. She outlined the impact which the collapse of the airline would have personally on her and her colleagues financially, their lack of knowledge regarding the benefits system and moving forward. She then highlighted the number of workers who would be affected and the impact the collapse of Flybe would have on the passengers who used the service.

Mr. Robb highlighted the fact that Flybe had successfully provided a service to Northern Ireland for the past forty years. He referred to the Airport Operators Certificate, which was held by Flybe, which any airline needed to operate commercially and which would only be in place for less than 30 days, therefore time was of the essence to salvage the situation. He referred to the daily flights and routes undertaken by Flybe and indicated that no other airline was in a position to replace those, and therefore support the Northern Ireland economy, as they were more leisure orientated and were currently scaling back operations due to COVID-19, and did not have the resources in place to operate a seventy aircraft network. He concluded by highlighting the services the company provided and the class of passengers, such as business, sporting and leisure, who used the service.

The Lord Mayor thanked the deputation for their presentation.

The Council noted the information which had been provided and that it would have an opportunity to discuss the issue later in the meeting.

**Motion – Flybe Airline**

Moved by the Lord Mayor, Councillor D. Baker,  
Seconded by Councillor McAteer,

“This council notes with grave concern the situation that is unfolding due to the collapse of Flybe. Flybe represented 80% of the total air routes operated through Belfast City Airport.

This collapse meant that overnight hundreds of staff lost their jobs, causing huge devastation and despair for those affected. Therefore Belfast City Council through our economic development unit will work with those affected staff where possible to help them seek an alternative job in the industry through academy's, advice and offer a retraining programme if deemed necessary.

Furthermore, this council is aware of the severe economic impact the collapse of Flybe could have on the local economy. Flybe operated several key routes which were essential for an island economy. It is crucial for this City's economy that these vital air routes are restored.

As a result, this council will conduct an urgent meeting consisting of the Minister for Economy, Trade Unions, Belfast City Airport and the Belfast MPs to come together and discuss ways to how we can collectively work together to help the staff at Flybe, mitigate the economic impact the FlyBe collapse has on the local economy and to try and restore the vital air links to our City.

At the request of Councillor Heading, the proposer agreed to amend his motion to allow for the inclusion of “and MLAs from each of the Political Parties” after MPs in the final paragraph.

After discussion, the motion, as amended, was put to the meeting and passed.

The Council further agrees to work with the Public Health Agency and the Northern Ireland Executive seeking support from Department for Communities to make a series of interventions to protect those most at risk including older people and these whose immunity may be impaired. In addition, Council requests that support be provided to employees who are not normally protected by statutory sick pay in these circumstances.

The Council agrees to request that the Department of Finance create a package of measures to mitigate the worst impact of closures and potential city-wide restrictions on small businesses and charities, as well as actions to support community based enterprises, including childcare organisations, and other social enterprises that are a mainstay of the local economy.

The Council will continue to liaise closely with Chief Medical Officer and Public Health Agency. The Council agrees a joint press statement will be issued tonight on behalf of all parties.”

### **Explanation of the Agenda and the Meeting**

The Chief Executive provided the Council with an update on the latest actions and plans which the Council's Emergency Planning teams had been involved in. She also advised the Members that business continuity planning was in place for each of the Council's critical services.

She advised the Council that, in response to the decisions taken at its meeting on Friday, 13th March:

- the City Hall was closed to the public, with the exception of registering births, deaths or marriages, or for weddings and civil partnership ceremonies which had already been booked;
- all other functions or events in the City Hall would be cancelled until further notice;
- Malone House and Belfast Castle would be closed to the public, apart from those functions which had already been booked at those venues;
- The Tropical Ravine, the Palm House and Belfast Zoo were closed to the public until further notice; and
- Pitches and pavilions would be closed until further notice.

She explained that the Special Council meeting had been called by the Lord Mayor to discuss a proposal calling on all Leisure Centres across the City to close, as well as to discuss any other issues relating to the Coronavirus (Covid 19) outbreak.

This Council, in light of the Coronavirus outbreak, calls on Greenwich Leisure Limited (GLL) to close all of its Leisure Centres in Belfast immediately.

In the interest of public health, and to protect staff and the public, this Council will temporarily close major services to the public, including leisure centres, and events centres like the Ulster Hall and the ICC Belfast. Community Centres will also shut, but can remain in use for exceptional or unnecessary meetings and to help the vulnerable where needed. All workers who can be redeployed or can work from home will be facilitated. Parks and Cemeteries will remain open, but playgrounds will shut. Necessary services, such as recycling centres and cleansing will remain open. The Council also calls on bars to shut over the St. Patrick's Day period. While this shutdown occurs, Council management and elected representatives will work with the relevant Stormont departments to develop a relief system for workers and the self-employed throughout this crisis.
