<b>1.0</b>	<b>Purpose of Report/Summary of Main Issues</b>
1.1	To consider the Notice of Motion received for the meeting of the Council on 1st October, 2025 in relation to Community Orchards.
<b>2.0</b>	<b>Recommendation</b>
2.1	<p>Members are asked to note that, in accordance with Standing Orders, Notices of Motion which commit the Council to expenditure or falls within the remit of a particular Committee must be referred to the appropriate committee for consideration and report.</p> <p>At this time Members are only asked to note that the Notice of Motion has been received and that a subsequent report will be brought to Committee, if that Committee so agrees, outlining a detailed consideration of the Notice of Motion and the potential costs implications.</p> <p>The Committee is asked to note that this motion will be referred on the first instance to the People and Communities Committee.</p>
<b>3.0</b>	<b>Main Report</b>
3.1	<p><b><u>Key Issues</u></b></p> <p>The Committee will be aware that Standing Orders 13 (m) to (r), as agreed by the Council at its meeting on 4th October, are as follows:</p> <ul style="list-style-type: none"> <li>(m) <i>The Standards and Business Committee will have delegated authority to adopt or reject Notices of Motion. The Lord Mayor will indicate at the Council meeting those Notices of Motion that have been considered by the Standards and Business Committee and whether such Notices of Motion were rejected or adopted. In either case, the proposer only may speak on the issue at Council.</i></li> <li>(n) <i>The Standards and Business Committee will refer all Notices of Motion directly to a standing committee when the matter to which the Notice of Motion refers falls within the remit of that committee. At Council, the Lord Mayor will indicate that the Notice of Motion was received and referred. There will be no speakers on such Notices of Motion at Council.</i></li> <li>(o) <i>The Standards and Business Committee will refer Notices of Motion for consideration by full Council when the Notice of Motion relates to a strategic or constitutional matter.</i></li> <li>(p) <i>The Standards and Business Committee will not have the power to amend the wording of any Notice of Motion that is being referred to the full Council for debate.</i></li> <li>(q) <i>Any amendments to Notice of Motions to be proposed at the Council are to be furnished at least one day in advance of going to the full Council and will be circulated to Party Group Leaders in advance of the Council meeting.</i></li> </ul>

3.2	<p>(r) <i>In referring any matter to the full Council, the Standards and Business Committee may determine to restrict contributions to the debate in relation to any Notice of Motion to one per political party. At the Council meeting, the Lord Mayor will clearly indicate if the restriction applies.</i></p>
	<p>The following motion has been received:</p> <p><b><u>Community Orchards</u></b></p> <p>This Council recognises the wide-ranging social, environmental, and economic benefits of community orchards, including increased access to fresh fruit, the promotion of local food resilience, the enhancement of green spaces, improved mental and physical wellbeing, and stronger community cohesion. It acknowledges that community orchards contribute to climate resilience through increased biodiversity, carbon sequestration, and natural cooling effects in urban areas. It also notes that community orchards offer valuable opportunities for intergenerational learning, volunteering, and environmental education, particularly in areas where green space and access to nature are limited.</p> <p>This motion is requesting that this council commits to supporting the creation and maintenance of community orchards across the city through partnerships with residents, schools, and local organisations. Council will take part in identifying underused or neglected public land that could be repurposed for community orchard use. This would require commitment to some expenditure for planting, equipment, and training necessary to establish new orchards in identified areas. Council would also encourage and support community-led management of orchards and provide resources and guidance to support their long-term sustainability.</p> <p>Proposer: Councillor Christine Bower</p> <p>Seconder: Councillor Fiona McAteer</p>
3.3	<p>The motion calls upon the Council to commit to supporting the creation and maintenance of community orchards across the city through partnerships with residents, schools, and local organisations. The People and Communities Committee is responsible for the development and implementation of strategies, policies, programmes and projects aimed at improving life at a local level in the context of the outcomes agreed in the community and corporate plans and other corporate strategy. In addition the motion also has links to a previous motion on the Vital Role of Trees and the motion will therefore be referred to that Committee.</p>
