



ENTERTAINMENTS LICENCE
Local Government (Miscellaneous Provisions) (N.I.) Order 1985
Article 3, Schedule 1 – Licensing of Places of Entertainment

The Council of the City of Belfast, in pursuance of the provisions of Article 3 of, and Schedule 1 to, the Local Government (Miscellaneous Provisions) (Northern Ireland) Order 1985, hereby grants

a licence to **El Divino Belfast Limited**

Ref: **LN/200200427**

hereinafter referred to as the Licensee, for the use of the place

known as **El Divino**

and situated at **Mays Meadow, Laganbank Road, Belfast, BT1 3PH**

from **1st December 2013** until **30th November 2014** inclusive,

in the said City for the purpose of the entertainments listed in the Schedule hereunder and subject to any restrictions or special conditions as may be also listed hereunder, unless the same shall have been previously transferred, cancelled, varied, suspended or revoked; provided that the Licence is granted on the terms and conditions and subject to the restrictions as are specified in the Conditions thereof and shall be liable to be revoked if the Licensee is convicted of an offence in respect of the Place being used for any entertainment otherwise than in accordance with the terms, conditions or restrictions on or subject to which the Licence is held and shall be liable to be suspended if it appears to the Council that the provision of any entertainment at the Place is causing or is likely to cause a serious threat to public order or public safety.

Special Conditions/Restrictions

- 1. Licensee to attend meetings, as and when required, with the PSNI and a representative group drawn from local residents, chaired by the Council, to discuss issues relating to entertainments licensing.**
- 2. Any drinks promotions permitted must be strictly in accordance with the Pubs of Ulster Code.**
- 3. Management to employ the services of a security company to control patrons and on Laganbank Road from 9pm, when the premise is providing entertainment.**
- 4. Management to implement measures to control traffic on Laganbank Road.**
- 5. The licensee must ensure that noise from patron dispersal does not cause unreasonable disturbance to persons in the neighbourhood.**
- 6. Management to erect signage and provide announcements at the end of the night asking the patrons to respect the residents in the area and keep the noise to a minimum.**
- 7. Entertainment may be provided on Sunday until 2.00 am the following morning on the occasions where the following day is a Bank or Public Holiday.**
- 8. On Sunday 26th May and Sunday 25th August 2013 entertainment may be provided until 3.00 am the following morning.**

The following conditions apply when entertainment is being provided:

- 9. Occupancy figures shall be controlled to ensure that the numbers on each floor do not exceed those stipulated on the licence.**
- 10. All emergency exit routes to be kept clear.**
- 11. Shutters outside final exit doors to be secured in open position to ensure that they will not impede escape.**
- 12. All doors on means of escape to be free from restrictive fastenings other than panic bolt type mechanisms.**
- 13. Windows and Acoustic shutters to be locked closed at all times.**
- 14. 2nd Floor Balcony closest to the neighbouring St John's Wharf Apartments is not permitted for use.**
- 15. All entertainment must be provided through the noise limiter set at the level which has been agreed by the Health and Environmental Services Department. This limiter level may be subject to change if noise nuisance occurs.**
