# **Relevant Background Information**

The Council holds a portion of Lenadoon Millennium Park by way of a 10,000 year lease from the Northern Ireland Housing Executive (NIHE). The lease includes a restriction on use of the land to "informal open space". At it's meeting on 14 April 2011 the Parks and Leisure Committee is being asked to consider seeking a relaxation of this restrictive covenant to allow development of a community facility and changing accommodation on approximately 43.32 square metres of this site. The cost to the Council of achieving this relaxation has been assessed by the District Valuer, Land & Property Services (acting on behalf of NIHE) at £1000.

The above mentioned proposed community facility and changing accommodation is to be developed by Lenadoon Community Forum (LCF) with grant aid from Sport NI. LCF are acquiring adjoining land from NIHE and are also seeking to acquire the additional strip of 43.32 square metres at Lenadoon Millennium Park, from the Council.

The attached report and maps (Appendix 1) which are being presented to the Parks and Leisure Committee, provide the Parks and Leisure Committee with three options in relation to the net price payable in respect of relaxation of the restrictive covenant and onward disposal of the 43.32 square metres to LCF. The Director of Property and Projects will provide a verbal update to Members on the outcome of the Parks and Leisure Committee Meeting.

The Strategic Policy and Resources Committee are being asked to consider the Parks and Leisure Committee decision in accordance with Standing Orders 46 and 60 and approve it if appropriate.

#### **Key Issues**

Following a decision of the Parks and Leisure Committee on 14 April 2011, approval is sought to the terms of disposal of approximately 43.32 square metres of land at Lenadoon Millennium Park to Lenadoon Community Forum.
