1	RELEVANT BACKGROUND INFORMATION	
1.1	As part of the Local Government Reform Programme, the Councillors' Remuneration Panel for NI is conducting a review of councillors' remuneration and advising on the system and level of allowances appropriate for the 11 new councils.	
1.2	The Panel has been asked to make recommendations that fairly reflect the roles and responsibilities that councillors will be taking on in the new councils, post reorganisation in April, 2015. It is also considering the allowances that should be paid during the shadow period following the local government elections in 2014 when the new councils will operate alongside the existing 26.	
1.3	The Panel was appointed on 1st May 2013 and had initially been given six months to submit its final recommendations to the Department of the Environment.	
2	KEY ISSUES	
3.1	The DoE has written to the Council, copy attached at Appendix 1, giving notification of a number of focus group engagement events which have been scheduled for local government and other stakeholders to discuss the emerging proposals of the Remuneration Panel and to inform the finalisation of the scheme of allowances that will apply. A Belfast based event is scheduled for 10 February 2014, 10am-1pm in Grosvenor House Conference Centre, 5 Glengall Street.
