### BRIDGE STREET & NORTH STREET, BELFAST – PROPOSED TAXI-BUS RANKS

North Belfast Taxis Association operate a Taxi-Bus service from two locations in Belfast City Centre, Bridge Street and North Street. This is a completely different operation than that of the Private Hire and Public Hire taxi industries and has been operating on an unofficial basis for a number of years from the locations proposed below.

Some years ago they asked TransportNI to provide taxi ranks and signage, which, at the time, we did not have the legislative powers to do. However, under the recently made Passenger Transport (Service Agreements and Service Permits) Regulations (NI) 2015 coming into operation on 5<sup>th</sup> October 2015, we can now provide ranks and signage and propose to introduce ranks for this operation as described below.

- Bridge Street (southwest side) – From its junction with the southeast side of Rosemary Street, south-eastwards for a distance of 10 metres.
- North Street (south side) – From its junction with the east side of Law's Court, westwards for a distance of 20 metres.
