#### **EXTINGUISHMENT OF PUBLIC RIGHTS-OF-WAY**

# THE HOUSING (NORTHERN IRELAND) ORDER 1981

NOTICE is hereby given that the Northern Ireland Housing Executive, having its principal office at 2 Adelaide Street in the City of Belfast, in pursuance of its powers under Article 88D of the Housing (Northern Ireland) Order 1981, on 10th August 2015 made an Order, which will be submitted to the Department for Social Development for approval, ordering that the Public Rights-of-Way described in the Schedule hereunder be extinguished.

The Housing (Northern Ireland) Order 1981 provides that an Order shall not have effect until approved by the said Department and that an Order to which any objection is made and not withdrawn shall not be approved until a local public inquiry is held into the matter.

Belfast, Lawnbrook 2 RDA 143 Extinguishment of Public Right-of-Way Order No. 3, 2015

**Battenberg Street** 


- Passageway alongside No. 2 Battenberg Street and passageway to the rear of Nos. 2-44 Battenberg Street.

**Brookmount Street** 

- That part of Brookmount Street between its junction with Azamor Street and a line drawn across Brookmount Street from a point on the front corner of No. 7 Brookmount Street to a point on the footpath opposite and thence along the footpath to a point in line with the rear corner of No. 340 Shankill Road.
- Passageway alongside No. 2 Brookmount Street.

Glenwood Street

- That part of Glenwood Street between its junction with Azamor Street and a line drawn across Glenwood Street from a point on the rear corner of Nos. 326/328 Shankill Road to a point on the gable wall of of No. 330 Shankill Road.
- Passageway alongside No. 1 Glenwood Street and passageway to the rear of Nos. 1-59 Glenwood Street; passageway alongside No. 4 Glenwood Street and passageway to the rear of Nos. 4-64 Glenwood Street.
