Executive Summary:

Full planning permission is sought for the removal of Condition No. 5 of Z/2014/1279/F relating to the signalised junction.

The Development plan zones the site for mixed use. It is identified in the plan as zoning BH05-Mixed Use Site|North foreshore.

The main issue to be considered in this case is:

1. The principle of the removal of condition 5 at this location.


Condition 5 states that "The development hereby approved shall not be commenced until details of the signalised junction have been submitted to and approved by Belfast City Council. These details must be in accordance with the Design Manual for Roads and Bridges."

Transport NI (TNI) offered no objections to the removal of condition 5 of planning approval Z/2014/1279/F on the basis that this planning permission relates only to site capping and a construction of a new road (no trip generation other than those involved in capping and construction) and therefore the trigger in terms of daily vehicular movements for the signalised junction will not be reached.

No representations were received.

Recommendation

It is recommended that the removal of condition 5 of planning permission Z/2014/1279/F is approved

2.0	Description of Site		
	The site is located off Dargan Road and contains a capped landfill site run by Belfast City Council. It consists of undulating ground with a new recently constructed road network for service vehicles. To the north and east of the site is Belfast Lough.

No letters of objection have been received. 8.0 Other Material Considerations 8.1 N/A 9.0 Assessment 9.1 The key issues in the assessment of the proposed development include: The principle of the removal of condition 5 of planning permission. 92 Condition 5 of Z/2014/1279/F states that 'the development hereby approved shall not be commenced until details of the signalised junction have been submitted to and approved by the Department. The applicant is seeking variation of this condition to the development of the proposed signalised junction onto Dargan Road shall not be commenced until details of the junction have been submitted to and approved by Belfast City Council'. 9.3 Transport NI under the consideration of previous planning approval Z/2014/1279/F for the provision of new upgrade of existing roads infrastructure and associated site capping together with associated landscaping and site works had some concern with the junction

layout. The main concern arises from the inability to fully define traffic flows to and from the site without further knowledge of the future developments / tenants. As Z/2014/1279/F related to site capping and the construction of a new road it was accepted that there would be minimal traffic movement and it was premature to impose a condition relating to the signalised junction if the trigger in terms of traffic trips would not be reached.

9.4 It is considered that any future planning applications for sites/ development proposals within the North foreshore zoning can be assessed on a case by case basis. It is also considered that these applications may require to be accompanied by a Transport Assessment Form (TAF) or a Transport Assessment (TA) and through consultation within TNI it can be assessed as to whether the trigger in terms of trips generated has been reached for the construction of the signalised junction and at that stage a negative condition can be attached to any planning approval to ensure that these engineering works are carried out.

10.0 Summary of Recommendation: Approval

Having regard to the development plan, relevant planning policies and other material considerations, it is determined that the development will not cause demonstrable harm to the interests of acknowledged importance. Approval is therefore recommended.

11.0 Informatives

1. This permission relates solely to the removal of condition 5 of Z/2014/1279/F. All other conditions set out under Z/2014/1279/F must be complied with.
