I, John Pollock, Chief Executive of the Loughs Agency, Foyle, Carrington and Irish Lights Commission, hereby certify that the Commission is satisfied that the number of salmon which have migrated upstream of the River Finn Fish Counter during each of the previous five years has not exceeded 5,410, stipulated by the Foyle Area (Control of Fishing) Regulations 2010.
