

**Abandonment – Lisburn Road, Belfast**

The Department for Infrastructure (DfI) gives notice of its proposal to abandon an area of 498.254 square metres of road comprising a bus turning circle adjacent to Balmoral Golf Club, **Lisburn Road, Belfast**, after the completion of such works as the Department considers necessary. The area of road proposed to be abandoned is delineated on a map which, together with a copy of a draft order, may be inspected free of charge during office hours within the period 27 September 2017 to 6 November 2017 at DfI Roads Eastern Division, Hydebank, 4 Hospital Road, Belfast, BT8 8JL or by viewing online at [www.infrastructure-ni.gov.uk/consultations](http://www.infrastructure-ni.gov.uk/consultations)

Order (Northern Ireland) 2017**

The Department for Infrastructure(a) makes the following Order in exercise of the powers conferred by Article 68(1) and (5) of the Roads (Northern Ireland) Order 1993(b) and now vested in it(c).

The Department in accordance with Article 68(4) of that Order proposes on the completion of works providing alternative facilities for road traffic to abandon the area of road described in the Schedule.

Notice has been published, served and displayed in compliance with paragraphs 1, 2 and 3 of Schedule 8 to that Order.

**Citation, commencement and interpretation**

- 1.—(1) This Order may be cited as The Lisburn Road Bus Turning Circle, Belfast (Abandonment) Order (Northern Ireland) 2017 and shall come into operation on 2017.
- (2) In this Order “the Contractor” means A G Wilson Limited, whose registered office is situate at 8 Upper Ballydougan Road, Portadown, Craigavon, Co. Armagh, BT63 5NU.

**Application**

2. The Contractor shall carry out such works as the Department considers necessary for the provision of alternative facilities for road traffic and on completion of the works the area of road described in the Schedule is abandoned.
- 3.—(1) All existing cables, wires, mains, pipes or other apparatus placed along, across, over or under the abandoned area of road shall be retained.
- (2) All existing rights as to the use or maintenance of such cables, wires, mains, pipes or other apparatus shall be preserved.

### AREA OF ROAD TO BE ABANDONED

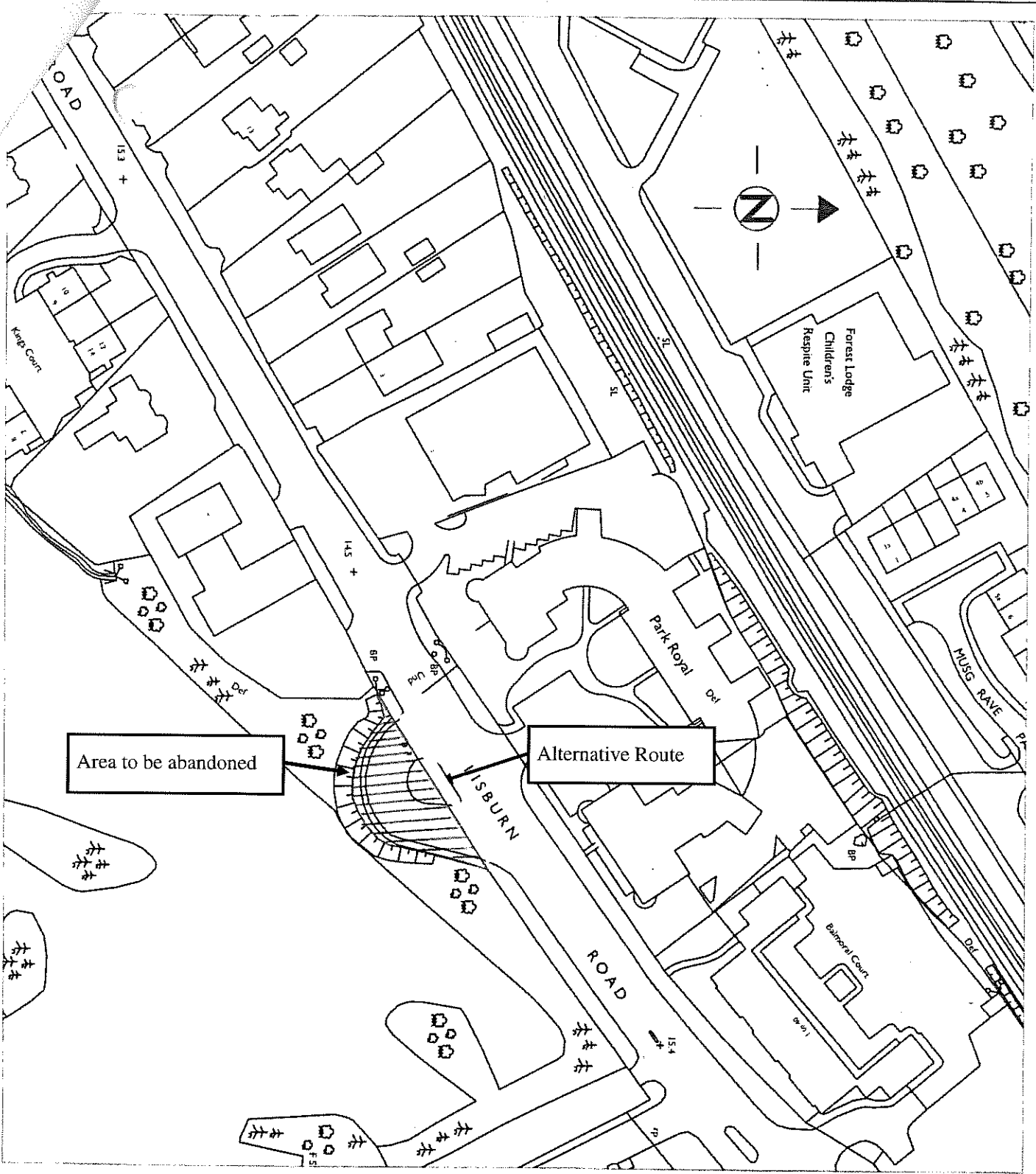
