NOTICE OF INTENDED ENTRY 263-285 BEERSBRIDGE RD, FOUL AND STORM SEWER NEW

The enclosed Notice of Intention is served under the Water and Sewerage Services (NI) Order 2006, (the 2006 Order), which repealed and replaced the Water and Sewerage Services (NI) Order 1973. This fee will normally be approved by the District Valuer or Northern Ireland Water's Estates Professional Services provider. If you wish, the fee can be paid directly to an Agent, however, written authority will be required from you.

I should be grateful if you would let me have the name and address of any occupant, tenant or licensee who may be occupying the land affected by the proposed works. Please also advise if the area is infected by a disease notifiable under the Diseases of Animals (NI) Order 1981.
