<p>Executive Summary:</p> <p>A pre-determination hearing was held on 13th February 2018. At the hearing officers presented details of the scheme in its context and provided an overview of the proposal. Committee received representations from Save CQ, Ulster Architectural Heritage Society and the First Presbyterian Church in objection to the application and from Savills and Consarc on behalf of the applicant in support of the application. The issues raised at the hearing have been considered in the assessment of this application.</p> <p>Members agreed at the pre-determination hearing to defer consideration of the application for a site visit which took place on 21st February 2018. Members viewed the building to be demolished from Rosemary Street and the rear of Central Halls.</p> <p>Conservation Area Consent is sought for the demolition of the building at No. 27-31 Rosemary Street.</p> <p>The site is located within Belfast City Centre Primary Retail Core. It falls within Belfast City Centre Conservation Area and sits between two listed buildings Central Halls and the Masonic Hall.</p> <p>One representation of objection has been received. The objection, submitted on behalf of the owners of the property at No's. 27-31 Rosemary Street, is against the proposed demolition works and makes request that the application should be withdrawn.</p> <p>The main issues to be considered in the assessment of this proposal are:</p> <ul style="list-style-type: none"> • The principle of demolition • Impact on the Conservation Area • Impact on the setting of listed buildings <p>The proposal has been assessed against the development plan context and relevant planning policy and complies with the policy.</p> <p>Planning permission was previously granted for a comprehensive development scheme (Ref:</p>	

Z/2010/1532/F & LA04/2016/2327/F) which included demolition of this building. Conservation Area Consent was also granted for the demolition of this building within the context of the consented scheme (Ref: Z/2010/1495/DCA and LA04/2016/1622/DCA). The previous permissions established the principle of demolition of the building.

Recommendation

Having regard to the policy context and other material considerations, the proposal is considered acceptable. It is recommended that consent be granted subject to conditions and that the consent be linked to the proposals for Phase 1B (Ref: LA04/2017/2126/F) through a Section 76 Agreement

It is requested that authority is delegated to the Senior Authorised Planning Officer, in consultation with the City Solicitor, to negotiate the terms of the Agreement and to determine the final wording of conditions.

If members are minded to approve the application, the Council will be required to notify DFI given under Sections 105(6) of the Planning Act (Northern Ireland) 2011.

Characteristics of the Site and Area

1.0	Description of Proposed Development

	The proposal is for the demolition of the building.
2.0	<p>Description of Site</p> <p>The site, identified as No's. 27-31 Rosemary Street, Belfast, is linked to planning application reference LA04/2017/2126/F. It comprises a four-storey property located between the Masonic and Central Halls at No. 15 and Nos. 37-39 Rosemary Street. The property is rendered and contains a double-height retail frontage with three smaller windows off-set on the upper floors and separated by a disproportionate solid to void ratio. The rear of the property is finished in brick and contains large horizontal openings, one of which is infilled with block.</p> <p>The site is located within Belfast City Centre Primary Retail Core. It falls within Belfast City Centre Conservation Area and within a listed building curtilage.</p> <p>The building is currently occupied by B&M Bargains.</p>

3.0	<p>Planning History</p> <p>Z/2010/1532/F - Demolition, redevelopment and part change of use of existing buildings to create mixed use development comprising retail, offices, café/bar use, 2no. retail pavilions, 205 apartments including 6 no. live/work units, with associated energy centre, service areas and above ground car parking, cultural/arts centre, hotel, 2-level basement car park and associated access and circulation, creation of new streets and public spaces, reconfiguration of Writers Square, public realm works, landscaping and associated site and road works. Application also comprises works to restore, alter and extend listed buildings and facades and partial demolition of North Street Arcade retaining its facades, partial reconstruction of end blocks and reconstruction of rotunda on original location. Permission granted 23 Jan 2017.</p> <p>LA04/2017/2126/F - Redevelopment including the construction of a new six storey building on the existing surface level car park and part change of use to create a mixed use development comprising retail units, restaurants and cafes, residential units, offices, church and related community floor space, new streets and public realm works. Demolition of 53 Royal Avenue and 27-31 Rosemary Street and restoration of Central Halls (37-39 Rosemary Street), Masonic Hall (15 Rosemary Street), 43/43a Rosemary Street and retention of 30-34 North Street (Amended plans and further information received). One representation of objection has been received. The objection, submitted on behalf of the owners of the property at No’s. 27-31 Rosemary Street, is against the proposed demolition works and makes</p>

	<p>request that the application should be withdrawn.</p> <p>The applicant has served the requisite notice of the intention to apply for demolition consent on the owners of 27-31 Rosemary Street and has satisfied legislative requirements. The applicant is entitled to apply for consent to demolish the building without having ownership of it. If consent is granted agreement would be required with the owner of the building to carry out the works.</p> <p>Other Material Considerations</p> <ul style="list-style-type: none"> • Belfast City Centre Conservation Area Guide <p>Conservation Area Consideration</p> <p>The Council's Conservation Officer was consulted in relation to the proposal and raised no objections.</p> <p>Principle for demolition</p> <p>The principle for demolition of the property at No's. 27-31 Rosemary Street has been established by previous approvals under planning references Z/2010/1532/F, LA04/2016/2327/F, LA04/2016/1622/DCA and Z/2010/1495/DCA.</p> <p>Phase 1A of the consented scheme has commenced which in effect means that the planning permission for the consented scheme remains live.</p> <p>Impact on Conservation Area and Listed Building Setting</p> <p>In considering the current proposal, Policy BH14 of PPS 6 applies. It states that the demolition of an unlisted building in a conservation area will normally only be permitted where the building makes no material contribution to the character or appearance of the area. It further states that where conservation area consent is granted this will normally be conditioned on prior agreement for the redevelopment of the site and appropriate arrangements for recording the building before its demolition.</p> <p>The property proposed for demolition does not make a material contribution to the character or appearance of the area and detracts from the adjacent listed buildings at No. 15, Nos. 37-39 and No. 41 Rosemary Street. The removal of the property is set within the context of planning application reference LA04/2017/2126/F in which the property will be replaced by a section of a new public street (Upper Lombard Street) and an extension to the Masonic Hall. The proposed Upper Lombard Street will result in increased city centre permeability and connectivity in providing a link-route from Rosemary Street through to North Street and will enhance the character and appearance of the conservation area.</p> <p>The removal of the property will also provide a visual gap between the Masonic and Central Halls to enhance the appearance of these listed buildings within the streetscape. Separate listed building consents have been submitted to include work to the external elevations along the proposed new 'Upper Lombard Street'. It is not considered that the proposed demolition will negatively impact on the Conservation Area or the setting of the listed buildings.</p>
5.2	<p>Having regard to the policy context and other considerations above, the proposal is considered acceptable. Planning permission is recommended subject to conditions and a Section 76 Agreement.</p> <p>It is requested that authority is delegated to the Senior Authorised Planning Officer, in consultation with the City Solicitor, to negotiate the terms of the Agreement and to determine the final wording of conditions.</p>

7.0	<p>Condition</p> <p>1. In accordance with Section 105 of the Planning Act (NI) 2011, the building shall not be demolished until a contract for the redevelopment of the site in accordance with the detailed proposals under application reference LA04/2017/2126/F has been agreed, and evidence of that contract submitted to and approved in writing by the Council.</p> <p>Reason: To ensure the implementation of a satisfactory replacement scheme in the interests of the Belfast City Centre Conservation Area.</p>
