Also attached is a plan, Drawing No 10, which shows the proposed new layout.

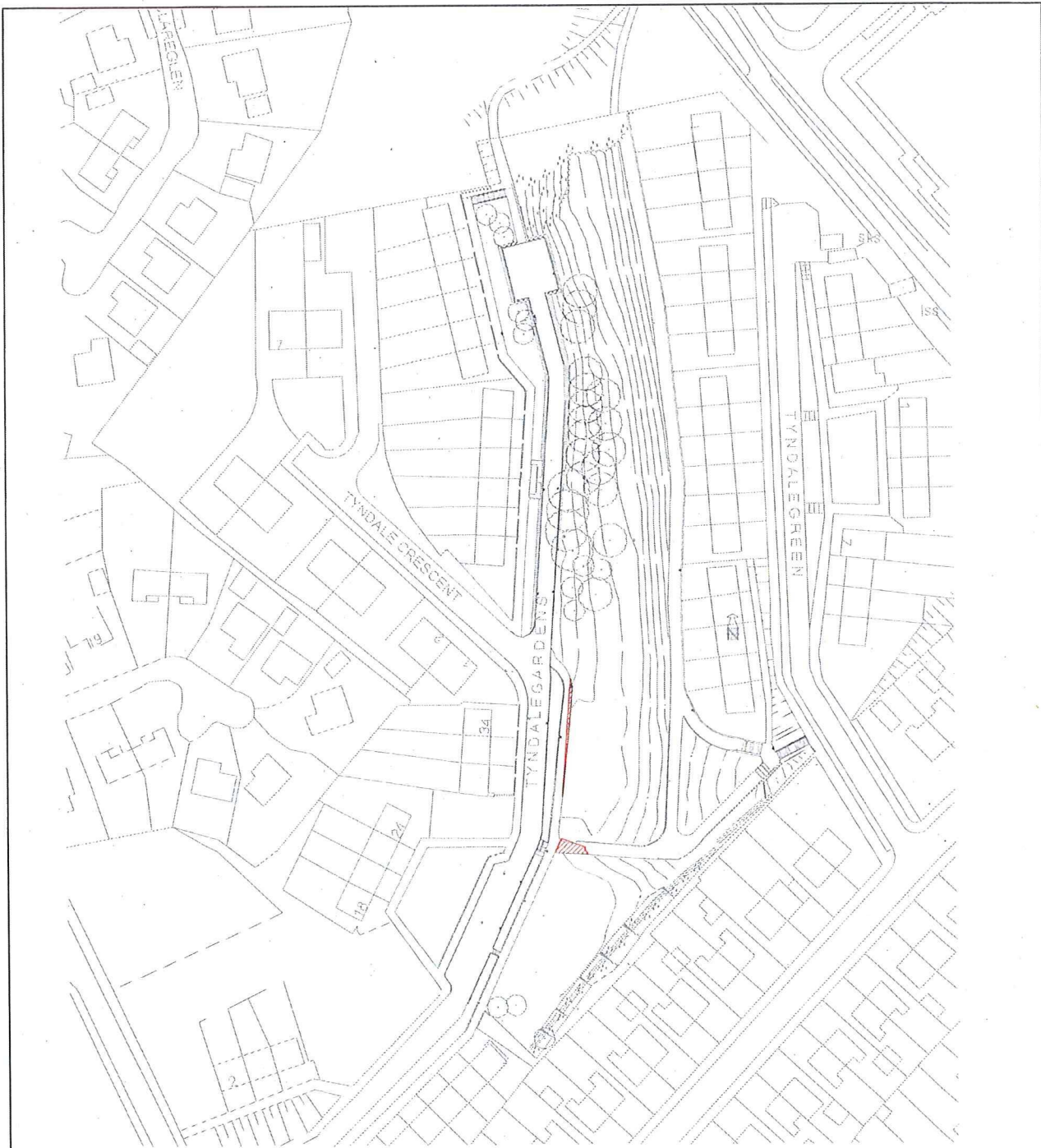
I should be grateful if you would indicate whether any of your equipment is located in the area affected by the proposal. If so, would you have any objections to this abandonment.

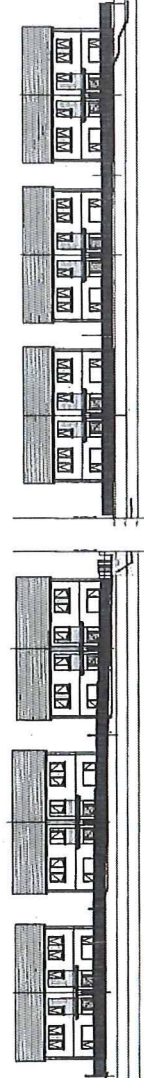
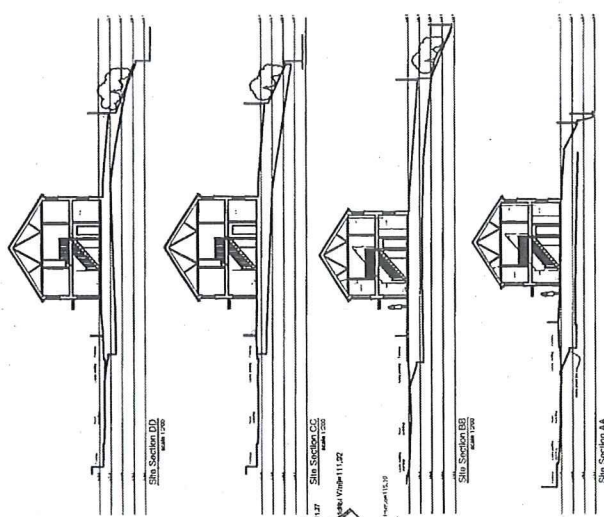
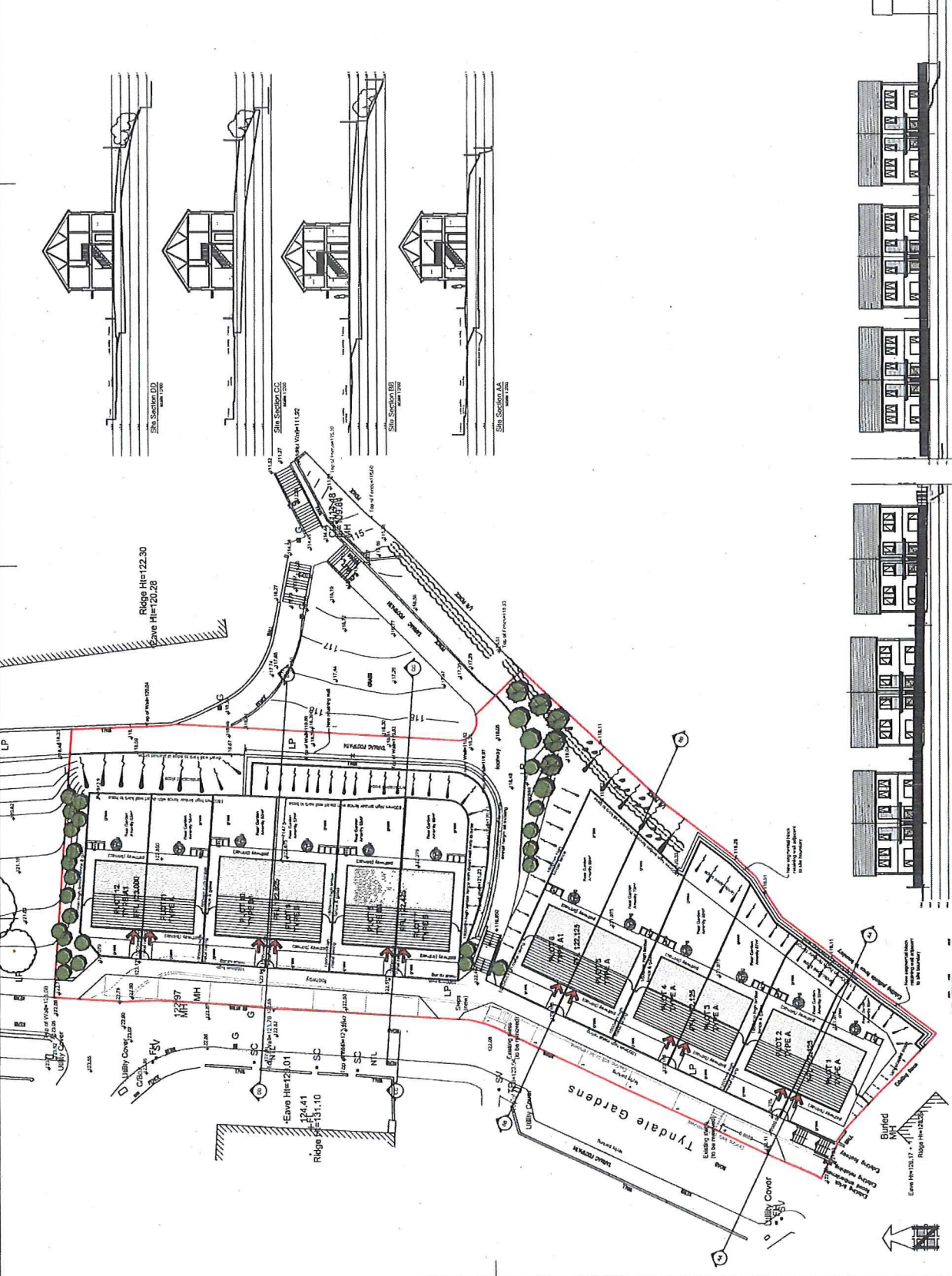
