	<p><b><u>KEY ISSUES</u></b></p> <p><b>Area Working Group Minutes</b></p> <p>3.1 Members agreed in June 2016 that the Area Working Group minutes would be taken into the SP&amp;R Committee for approval going forward in line with the Council’s commitment to openness and transparency and to ensure a consistent approach with other Member-led Working Groups.
