The Council agreed to appoint the Members to the Council's Standing Committees for 2020/2021, as set out above.

#### **Appointment of an Alderman**

The Chief Executive advised that the Local Government (Transitional, Incidental, Consequential and Supplemental Provisions) Regulations (Northern Ireland) 2015 permitted the Council, in an election year, to designate up to a maximum of fifteen Councillors to serve as Aldermen for the duration of the Council term.

The Council, at its Annual Meeting of 21st May, 2019, agreed that it wished to appoint seven Councillors to serve as Aldermen for 2019/2023.

The Chief Executive advised the Council that, upon the resignation of former Alderman Spence, a vacancy existed and the Council could decide whether it wished to fill the vacancy.

Moved by Alderman Kingston Seconded by Councillor Bunting and

Resolved – That Councillor Dorrian be appointed to the office of Alderman for the Council term.

### Change of Membership on Outside Bodies

The Chief Executive advised the Council that, following the recent casual vacancies, the DUP had indicated that it wished to make the following changes to the membership of Outside Bodies:

- Councillor Pankhurst to replace former Alderman Spence on the North Belfast District PCSP and the Reserve Forces and Cadet Association:
- Councillor Bunting to replace former Councillor Graham on the Forward South Partnership; and
- Councillor Dorrian to replace former Councillor Graham on the Somme Advisory Council.

The Council noted the changes.
